

RESOLUTION NO. 14-38

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, PINAL COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 26, 2014.

WHEREAS, the City of Maricopa, Pinal County, Arizona did hold a primary election on the 26th day of August, 2014 for the election of a Mayor, three Councilmembers for a 4-year term and one Councilmember for a 2-year term; and

WHEREAS, the election returns have been presented to and have been canvassed by the city council.

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Maricopa, Pinal County, Arizona as follows:

SECTION 1. That the total number of ballots cast for Mayor and Councilmember at said primary election, as shown by the poll lists, was 3712.
