THIRD AMENDMENT TO PURCHASE AND SALE AGREEMENT AND ESCROW INSTRUCTIONS

This Third Amendment to Purchase and Sale Agreement and Escrow Instructions ("Amendment") is made and entered into this 30th day of June June, 2021 (the "Amendment Effective Date"), by and between the City of Maricopa, an Arizona municipal corporation ("Seller"), and Urban Storage Maricopa, LLC, an Arizona limited liability company ("Buyer").

OPERATIVE PROVISIONS

NOW, THEREFORE, in consideration of the foregoing Recitals, which Recitals are incorporated herein by reference, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Buyer and Seller agree as follows:

1. <u>Close of Escrow</u>. Section 4.02, Closing, of the Agreement shall be deleted in its entirety and replaced with the following:

Subject to the Conditions Precedent set forth in Section 7 of the Agreement, the closing of this transaction and escrow (the "Closing" or "Close of Escrow") shall occur on or before September 30, 2021, unless otherwise agreed to in writing by both parties.

2. All other terms and conditions of the original Agreement, First Amendment and Second Amendment are to continue in full force and effect as stated and agreed to in the

Agreement dated November 23, 2020, the First Amendment dated January 25, 2021 and the Second Amendment dated April 22, 2021, as if fully set forth herein.
