Thank you very much Kath. I just spoke with Matt. There were several reason why we elected to go with En Pointe over Sentinel.

- 1. Nimble Storage, proposed by Sentinel, recently was purchased by HP (Now called HPE for HP Enterprise). HP has a poor track record when it comes to backend service. As much as I like Nimble (I installed them at Ak-Chin), I have real concerns that their service will decline.
- 2. En Pointe's quote included 3 year's worth of licensing and maintenance on the software and equipment...Sentinel only quoted 1 year.
- 3. En Pointe quoted \$25k for services. With a small team...and year end...we would like the vendor to rack the new equipment, copy data from the old equipment to the new equipment, move the old equipment to PD Substation, set up the old equipment at PD Substation, install replication software, ensure data is replicating between the two sites.

Good afternoon Kathleen. Attached please 5 find separate proposals compiled after approximately 8 months of exhaustive research and interviews by my team and me. In the end, we have chosen the proposal presented by En Pointe Partners. The quotes from NextNet and Avisolve were significantly higher than the others which ruled out those to vendors. Sentinel, En Pointe, and Davenport's quotes all were pretty close. However, within the last couple of months, HP purchased Nimble Storage...the solution presented by Sentinel. HP does not have a stellar record when it comes to support. Concern for that played into our decision to eliminate the Nimble solution.

That left Davenport Group who presented Dell/Compellent versus En Point and their Cisco/Tegile solution. From a technology perspective we liked both solutions. Dell was like hitting the "Easy" button as our current storage array. However, our concern there is that the Davenport Group is based out of Minneapolis with no presence in Arizona. Given no real edge on the technology side, our decision came down to after sales support. Therefore, we selected the local company, with local engineering expertise that can be onsite within 45 minutes should we have an issue.

I hope that helps to explain the rationale for our decision. As we must complete this effort before June 30 let me know what you need from us to get this onto the May 16 City Council agenda.
