

**RESOLUTION NO. 24-43**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, PINAL COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS, AS PROVIDED BY PINAL COUNTY, OF THE PRIMARY ELECTION HELD ON JULY 30, 2024.**

**WHEREAS**, the City of Maricopa, Pinal County, Arizona did hold a primary election on the 30<sup>th</sup> day of July, 2024 for the election of a Mayor and three Councilmembers for a 4-year term and a land sale proposition, Proposition 482; and

**WHEREAS**, on January 16, 2024, the City entered into an Intergovernmental Agreement with Pinal County for election services, which required Pinal County to tally official results of the election; and

**WHEREAS**, Pinal County has presented the election returns to the City Council, as provided in Exhibit A, and these returns have been canvassed by the City Council.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Maricopa, Pinal County, Arizona, based on the returns provided by Pinal County as set forth in Exhibit A, as follows:

**SECTION 1.** That the total number of ballots cast at said primary election, as shown by the poll lists, was 9,527.

**SECTION 2.** That the number of ballots rejected was 327.

**SECTION 3.** That the votes cast for the candidates for mayor were as follows:

**SECTION 6.** That it is hereby found, determined and declared of record, that proposition 482, a measure approving a land sale proposition passed by the following vote:

Yes: 4,854 votes

**SECTION 7.** This Resolution shall be in full force and effect immediately upon its adoption.
