LEGAL DESCRIPTION FOR  
SANTA CRUZ NORTH CHANNEL RIGHT OF WAY  
E.L.G. INVESTMENTS LLC PARCEL

That part of the East Half of Section 31, Township 4 South, Range 4 East of the Gila and Salt River Meridian, Pinal County, Arizona, more particularly described as follows:

Beginning at the Pinal County Aluminum Cap marking the Northeast Corner of said Section 31;

Thence South 00°27'25" West, along the East line of the Northeast Quarter of said Section 31, a distance of 2,643.84 feet to the Aluminum Cap marking the East Quarter Corner of said Section 31;

Thence South 00°27'32" West, along the East line of the Southeast Quarter of said Section 31, a distance of 2,643.99 feet to the Pinal County Highway Department Aluminum Cap marking the Southeast Corner of said Section 31;

Thence North 89°58'38" West, along the South line of the Southeast Quarter of said Section 31, a distance of 150.05 feet to a point on a line which is parallel with and 150.00 feet Westerly, as measured at right angles, from the East line of the Northeast Quarter of Section 6, Township 5 South, Range 4 East of the Gila and Salt River Meridian;

Thence North 01°26'08" East, along said parallel line, a distance of 2.42 feet to a point on a line which is parallel with and 150.00 feet Westerly, as measured at right angles, from the East line of the Southeast Quarter of said Section 31;

Thence North 00°27'32" East, along said parallel line, a distance of 2,642.71 feet to a point on a line which is parallel with and 150.00 feet Westerly, as measured at right angles, from the East line of the Northeast Quarter of said Section 31;

Thence North 00°27'25" East, along said parallel line, a distance of 2,643.40 feet to a point on a line which is parallel with and 150.00 feet Westerly, as measured at right angles, from the East line of the Southeast Quarter of Section 30, Township 4 South, Range 4 East of the Gila and Salt River Meridian;

Thence North 00°07'14" East, along said parallel line, a distance of 1.49 feet to a point on the North line of the Northeast Quarter of said Section 31;

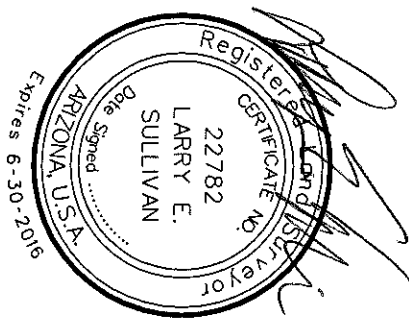
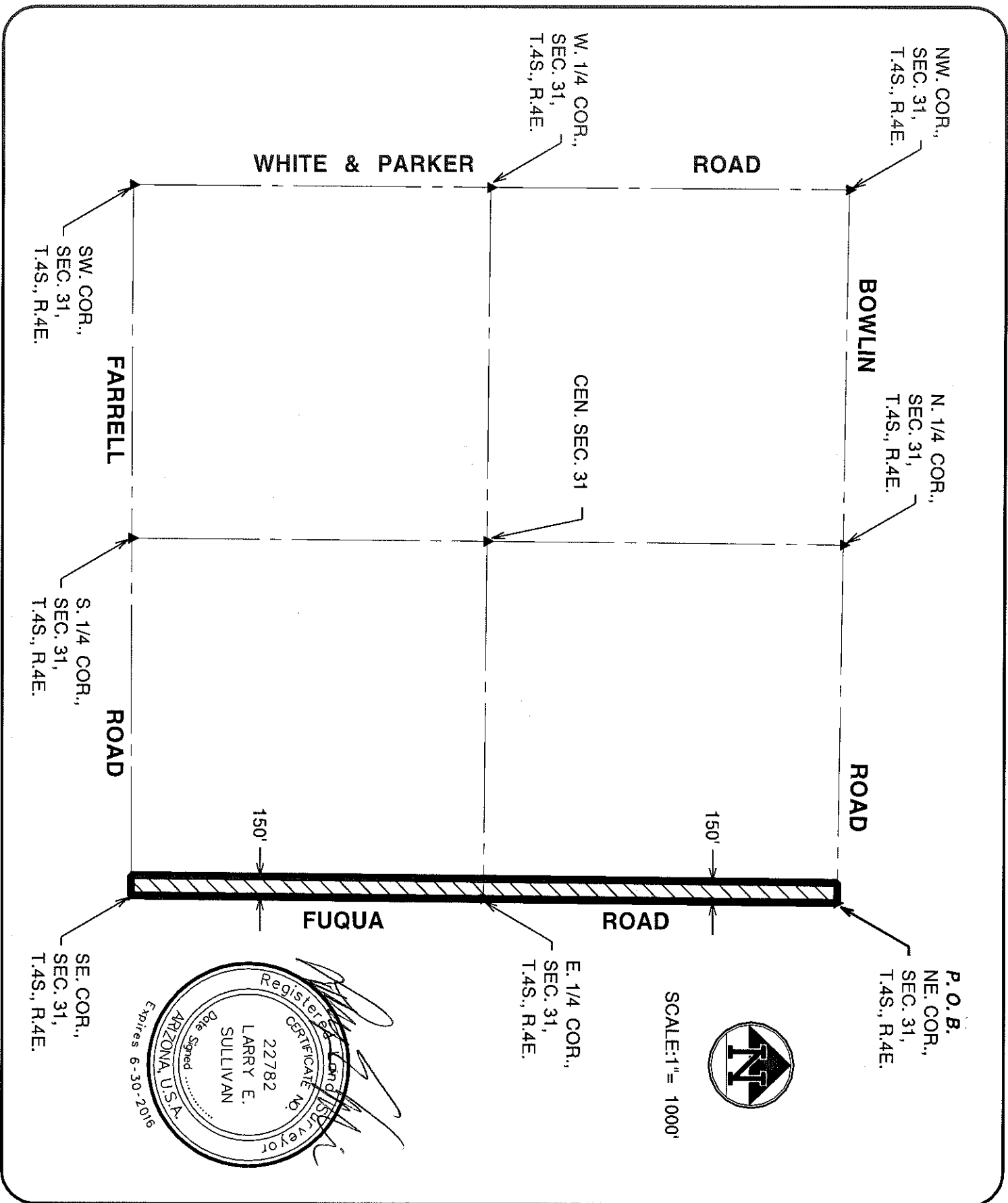
