

## RESOLUTION 14-50

### **A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AUTHORIZING THE IMPOSITION AND COLLECTION OF FEES FOR LICENSING AFTER-HOURS ESTABLISHMENTS, TEEN DANCE HALLS AND MAGIC ARTS ESTABLISHMENTS AND AMENDING THE SPECIAL BUSINESS LICENSE FEE SCHEDULE.**

**WHEREAS**, the Mayor and City Council wish to ensure all businesses in the City of Maricopa are regulated appropriately, in a clear and business-friendly manner; and

**WHEREAS**, the Mayor and City Council recognize that certain business types require special regulations because they raise unique concerns related to the health, safety, and public welfare of the City of Maricopa; and

**WHEREAS**, the City Council has determined the imposition and collection of fees to license after-hours establishments, teen dance halls and magic arts establishments is necessary to allow the City to issue these licenses, and that the persons primarily benefitting from such issuance should bear a reasonable portion of the costs therefore; and

**WHEREAS**, on September 2, 2014, the Maricopa City Council adopted Resolution 14-34 establishing the Special Business License Fee Schedule; and

**WHEREAS**, the City Council has determined that amending the Special Business License Fee Schedule is necessary to allow the collection of fees to license after-hours establishments, teen dance halls and magic arts establishments; and

**WHEREAS**, pursuant to A.R.S. §9-499.15, the City has provided written notice of the proposed charges on the home page of its website for at least sixty (60) days before the fees are considered by City Council.

**NOW, THEREFORE, BE IT RESOLVED** that the Maricopa City Council hereby authorizes the City to charge, in addition to other fees as may be specifically set forth by state law, Ordinance or Resolution, the fees as set forth in the amended fee schedules shown on Exhibit "A" hereto for the licensing of after-hours establishments, teen dance halls and magic arts establishments.

Three copies of the Fee Schedules established in Exhibit "A" shall be kept on file with the City Clerk and made available for public use and inspection.

The Maricopa City Council directs that all fees collected under this Resolution shall be deposited with the City's Director of Finance. The Director of Finance shall account for all fees deposited in accordance with the accounting policies and regulations adopted by the City.

Tobacco Retail*	\$275 / \$275	Year
After-hours Establishment*	\$250 / \$100	Year
Teen Dance Hall*	\$250 / \$100	Year
Magic Arts Establishment*	\$250 / \$100	Year
Background & Fingerprint Fee	\$50 Per Individual	Year
