RESOLUTION 14-54

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AUTHORIZING THE IMPOSITION AND COLLECTION OF FEES FOR LICENSING AND REGULATING THE COLLECTION, TRANSPORTATION, DISPOSITION OR RECYCLING OF RESIDENTIAL, COMMERCIAL OR INDUSTRIAL REFUSE GENERATED WITHIN THE CITY AND ESTABLISHING THE SOLID WASTE FEE SCHEDULE.

WHEREAS, the Mayor and City Council wish to ensure all businesses collecting solid waste in the City of Maricopa are regulated appropriately, in a clear manner; and

WHEREAS, the Mayor and City Council recognize that certain business types require special regulations because they raise unique concerns related to the health, safety, and public welfare of the City of Maricopa; and

WHEREAS, the City Council has determined the imposition and collection of fees to license and regulate the collection, transportation, disposition or recycling of residential, commercial or industrial refuse is necessary to allow the City to issue these licenses, and that the persons primarily benefitting from such issuance should bear a reasonable portion of the costs therefore; and

WHEREAS, the City Council has determined that establishing the Solid Waste Fee Schedule is necessary to allow the collection of fees to license and regulate businesses collecting solid waste in the City of Maricopa; and

WHEREAS, pursuant to A.R.S. §9-499.15, the City has provided written notice of the proposed charges on the home page of its website for at least sixty (60) days before the fees are considered by City Council.

NOW, THEREFORE, BE IT RESOLVED that the Maricopa City Council hereby authorizes the City to charge, in addition to other fees as may be specifically set forth by state law, Ordinance or Resolution, the fees as set forth in the fee schedule shown on Exhibit "A" hereto related to the licensing and regulating the collection, transportation, disposition or recycling of residential, commercial or industrial refuse.

Three copies of the Fee Schedules established in Exhibit "A" shall be kept on file with the City Clerk and made available for public use and inspection.

The Maricopa City Council directs that all fees collected under this Resolution shall be deposited with the City's Director of Finance. The Director of Finance shall account for all fees deposited in accordance with the accounting policies and regulations adopted by the City.

\$350 Annual Application Fee \$1,000 annual per vehicle fee or 4% of Gross Receipts, whichever is greater
