The City of Maricopa Express Transit (MET) has operated a transit system since 2008. MET operates as a service of the Finance Department. Today, MET operates two types of service: Local Demand Response 8:00 AM to 5:00 PM and Deviated Fixed Route, 8:00 AM – 4:00 PM. MET operates with a fleet of two 21-passenger buses, one 16-passenger bus, one 6-passenger minivan, and two 12-passenger vans. All services are Americans with Disabilities Act (ADA) compliant and open to the public.

Non-Discrimination ADA/Title VI Complaint Procedures

These procedures provide guidance for all complaints filed under Title VI of the Civil Rights Act of 1964, Section 504 of the Rehabilitation Act of 1973, and the Americans with Disabilities Act of 1990 (ADA) as they relate to any program or activity that is administered by the **City of Maricopa / MET** including consultants, contractors and vendors. Intimidation or retaliation as a result of a complaint is prohibited by law. In addition to these procedures, complainants reserve the right to file a formal complaint with other State or Federal agencies or to seek private counsel for complaints alleging discrimination. Every effort will be made to resolve complaints at the lowest possible level.

- (1) Any person who believes he and/or she has been discriminated against on the basis of race, color, national origin, or disability may file a Discrimination complaint by completing and submitting the agency's Title VI Complaint Form.
- (2) Formal complaints must be filed within **180** calendar days of the last date of the alleged act of discrimination or the date when the alleged discrimination became known to the complainant(s), or where there has been a continuing course of conduct, the date on which the conduct was discontinued or the latest instance of the conduct.
- (3) Complaints must be in writing and signed by the complainant(s) and must include the complainant(s) name, address and phone number. The ADA/Title VI contact person will assist the complainant with documenting the issues if necessary.
- (4) Allegations received by fax or e-mail will be acknowledged and processed, once the identity of the complainant(s) and the intent to proceed with the complaint have been established. For this, the complainant is required to mail a signed, original copy of the fax or email transmittal for the complaint to be processed.
- (5) Allegations received by telephone will be reduced to writing and provided to the complainant for confirmation or revision before processing. A complaint form will be forwarded to the complainant for him/her to complete, sign and return for processing.
- (6) Once submitted the **City of Maricopa / MET** will review the complaint form to determine jurisdiction. All complaints will receive an acknowledgement letter informing her/him whether the complaint will be investigated by the **City of Maricopa / MET** or submitted to the State or Federal authority for guidance.

- (7) **The City of Maricopa / MET** will notify the ADOT Civil Rights Office of ALL Discrimination complaints within 72 hours via telephone at 602-712-8946; or email at civilrightsoffice@azdot.gov.
- (8) **The City of Maricopa / MET** has seven (7) business days to investigate the complaint. If more information is needed to resolve the case, the Authority may contact the complainant. The complainant has seven (7) business days from the date of the letter to send requested information to the investigator assigned to the case. If the investigator is not contacted by the complainant or does not receive the additional information within seven (7) business days, the Authority can administratively close the case. A case can be administratively closed also if the complainant no longer wishes to pursue their case.
- (9) After the investigator reviews the complaint, she/he will issue one of two letters to the complainant: a closure letter or a letter of finding (LOF). A closure letter summarizes the allegations and states that there was not a Discrimination violation and that the case will be closed. An LOF summarizes the allegations and the interviews regarding the alleged incident, and explains whether any disciplinary action, additional training of the staff member or other action will occur.
- (10) A copy of either the closure letter or LOF must be also be submitted to ADOT within **72** hours of that decision. Letters may be submitted by hardcopy or email.
- (11) A complainant dissatisfied with the **City of Maricopa / MET** decision may file a complaint with the Arizona Department of Transportation (**ADOT**) or the Federal Transit Administration (**FTA**) offices of Civil Rights: **ADOT**: ATTN ADA/Title VI Program Coordinator 206 S. 17TH Ave MD 155A RM: 183 Phoenix AZ, 85007 **FTA**: Attention Title VI Program Coordinator, East Building, 5th Floor-TCR 1200 New Jersey Ave., SE Washington DC 20590

Limited English Proficiency Plan

The **City of Maricopa / MET** has developed the following Limited English Proficiency Plan (LEP) to help identify reasonable steps to provide language assistance for LEP persons seeking meaningful access to the **City of Maricopa / MET** services as required by Executive Order 13166. A Limited English Proficiency person is one who does not speak English as their primary language and who has a limited ability to read, speak, write, or understand English.

This plan details procedures on how to identify a person who may need language assistance, the ways in which assistance may be provided, training to staff, notification to LEP persons that assistance is available, and information for future plan updates. In developing the plan while determining the **City of Maricopa / MET**'s extent of obligation to provide LEP services, the **City of Maricopa / MET** undertook a U.S. Department of Transportation four-factor LEP analysis which considers the following:

- 1) The number or proportion of LEP persons eligible in the **City of Maricopa / MET** service area who may be served or likely to encounter by the **City of Maricopa / MET** program, activities, or services.

According to the U.S. Census Bureau, 23.3 percent of Maricopa's population speaks English less than "Very Well." This represents 2,114 Maricopa residents speaking various languages who speak English less than "Very Well." Under the U.S. Department of Justice's Safe Harbor Provision, it is necessary to translate materials when five percent or 1,000 persons, whichever is less, speaks English less than "Very Well." The Spanish-speaking population speaking English less than "Very Well" is comprised of 1,507 persons and therefore meets the U.S. DOJ's Safe Harbor Provision. For these reasons, MET provides key documents in Spanish, such as the MET User Guide, Title VI Notice to The Public, transit-related Public Meeting Notices, and any other transit-related events.

- 2) The frequency with which LEP individuals come in contact with **City of Maricopa / MET** services; **City of Maricopa / MET**'s staff reviewed the frequency with which office staff, dispatchers and drivers have, or could have, contact with LEP persons for **2025** . The **City of Maricopa / MET** averages **10** contacts per **MONTH**.

Since over 1,500 Spanish-speaking persons in Maricopa speak English less than "Very Well," this LEP population comes into contact with the MET with moderate frequency. Public meetings are

open to the general population and the City Of Maricopa Express Transit encourages all residents to attend transit-related public meetings and events. Because of the frequency of contact the MET has with this LEP population, we also provide key documents in English and Spanish.

- 3) The nature and importance of the program, activities or services provided by the **City of Maricopa / MET** to the LEP population.

Multimodal Transportation is extremely important to a rapidly growing community in the Sun Corridor Region of Arizona because traffic densities will limit roadway mobility in the future. For this reason, the City of Maricopa makes every effort to reach the Spanish-speaking population who speak English less than “Very Well,” by producing Spanish versions of key documents and offer translation service for public meetings and open house events upon request.

- 4) The resources available to the **City of Maricopa / MET** and overall costs to provide LEP assistance. A brief description of these considerations is provided in the following section.

The MET operates with limited funding and is working on expanding services. In planning for a larger transit system, Maricopa includes all populations, including the Spanish-Speaking LEP. In this manner, our system effectively serves ALL residents of Maricopa. We do so by providing key documents in Spanish and offer translation services.

The City of Maricopa / MET provides a statement in Spanish and will for additional languages specific to the LEP community make up that will be included in all public outreach notices. Every effort will be made to provide vital information to LEP individuals in the language requested.

Safe Harbor Provision for written translations

The City of Maricopa / MET complies with the Safe Harbor Provision, as evidenced by the number of documents available in the Spanish language. With respect to Title VI information, the following shall be made available in Spanish:

2) The **City of Maricopa / MET** has a process to ensure the competency of interpreters and translation service through the following methods:

The **City of Maricopa / MET** will ask the interpreter or translator to demonstrate that he or she can communicate or translate information accurately in both English and the other language. The **City of Maricopa / MET** will train the interpreter or translator in specialized terms and concepts associated with the agency's policies and activities. The **City of Maricopa / MET** will instruct the interpreter or translator that he or she should not deviate into a role as counselor, legal advisor, or any other role aside from interpreting or translator. The **City of Maricopa / MET** will ask the interpreter or translator to attest that he or she does not have a conflict of interest on the issues that they would be providing interpretation services.

3) The **City of Maricopa / MET** provides notice to LEP persons about the availability of language assistance through the following methods:

4) The **City of Maricopa / MET** monitors, evaluates and updates the LEP plan through the following process:

The **City of Maricopa / MET** will monitor the LEP plan by conducting an annual Four-Factor analysis, establishing a process to obtain feedback from internal staff and members of the public and conducting internal evaluations to determine whether the language assistance measures are working for staff. The **City of Maricopa / MET** will make changes to the language assistance plan based on feedback received. The **City of Maricopa / MET** may take into account the cost of proposed changes and the resources available to them. Depending on the evaluation, the **City of Maricopa / MET** may choose to disseminate more widely those language assistance measures that are particularly effective or modify or eliminate those measures that have not been effective. The **City of Maricopa / MET** will consider new language assistance needs when expanding transit service into areas with high concentrations of LEP persons will consider modifying their implementation plan to provide language assistance measures to areas not previously served by the agency.

5) The **City of Maricopa / MET** trains employees to know their obligations to provide meaningful access to information and services for LEP persons and all employees in public contact positions will be properly trained to work effectively with in-person and telephone interpreters. The **City of Maricopa / MET** will implement processes for training of staff through the following procedures:

The **City of Maricopa / MET** will identify staff that are likely to come into contact with LEP persons as well as management staff that have frequent contact with LEP persons in order to target training to the appropriate staff. The **City of Maricopa / MET** will identify existing staff training opportunities, as it may be cost-effective to integrate training on their responsibilities to persons with limited English proficiency into agency training that occurs on an ongoing basis. The **City of Maricopa / MET** will include this training as part of the orientation for new employees. Existing employees, especially managers and those who work with the public may periodically take part in re-training or new training sessions to keep up to date on their responsibilities to LEP persons. The **City of Maricopa / MET** will implement LEP training to be provided for agency staff. The **City of Maricopa / MET** staff training for LEP to include:

- A summary of the **City of Maricopa / MET** responsibilities under the DOT LEP Guidance;
- A summary of the **City of Maricopa / MET** language assistance plan;
- A summary of the number and proportion of LEP persons in the **City of Maricopa / MET** service area, the frequency of contact between the LEP population and the agency's programs and activities, and the importance of the programs and activities to the population;
- A description of the type of language assistance that the agency is currently providing and instructions on how agency staff can access these products and services; and

- A description of the **City of Maricopa / MET** cultural sensitivity policies and practices.

Title VI Equity Analysis

A subrecipient planning to acquire land to construct certain types of facilities must not discriminate on the basis of race, color, or national origin, against persons who may, as a result of the construction, be displaced from their homes or businesses. “Facilities” in this context does not include transit stations or bus shelters, but instead refers to storage facilities, maintenance facilities, and operation centers.

There are many steps involved in the planning process prior to the actual construction of a facility. It is during these planning phases that attention needs to be paid to equity and non-discrimination through equity analysis. The Title VI Equity Analysis must be done before the selection of the preferred site.

Note: Even if facility construction is financed with non-FTA funds, if the subrecipient organization receives any FTA dollars, it must comply with this requirement.

Fixed Route Transit Provider Analysis

Fixed Route: Public transit service (other than by aircraft) provided on a repetitive, fixed-schedule basis along a specific route, with vehicles stopping to pick up passengers.

A subrecipient providing fixed route service, as defined above, must determine the distribution of transit amenities or the vehicle assignments for each mode in a non-discriminatory manner. The subrecipient must develop policies to ensure service is not distributed on the basis of race, color, or national origin.
