

RESOLUTION NO. 12-19

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE ARIZONA DEPARTMENT OF TRANSPORTATION-TRANSPORTATION ENHANCEMENT DIVISION IN SUPPORT OF FUNDING THE BEAUTICATION OF STATE ROUTE 347 NORTH ENTRANCE OF THE CITY OF MARICOPA AND A SHARED-USE PATHWAY, SIDEWALK IMPROVEMENTS.

WHEREAS, the enhancement project named in this resolution is an eligible activity under the Transportation Equity Act for the 21st Century (TEA-21) that is administered by the Arizona Department of Transportation; and

WHEREAS, the City of Maricopa desires to submit an application to the Arizona Department of Transportation for the transportation enhancement program funds set forth by the Federal Transportation Equity Act for the 21st Century; and,

WHEREAS, Federal monies are available under a transportation enhancement program set forth by the Federal Transportation Equity Act for the 21st Century, administered by the Arizona Department of Transportation for the purpose of Historic, Scenic Beautification and Environmental, Pedestrian and Bicycle Projects; and

WHEREAS, After appropriate public input and due consideration, the Transportation Advisory Committee of the City of Maricopa has recommended that an application be submitted to the State of Arizona for a project which provides for the construction of a shared-use pathway adjacent to SR 347 hereinafter referred to as SR 347 from Edison Road (MP 174 to Entrance of Fry's Market Place, Maricopa; and the construction of a monument entry feature; SR 347 Monument Entry Feature at MP 173, Maricopa.

WHEREAS, The combined approximate budget of \$500,000 will fund the design and construction of the sidewalk on SR 347 and entry monument, including a 5.7% but not project overrun costs; and

WHEREAS, the City of Maricopa is responsible for any project overrun fees incurred during the design and construction phase as well as the ongoing maintenance of the projects upon completion.

NOW, THEREFOR, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF MARICOPA, ARIZONA THAT:

That the City of Maricopa, Arizona does hereby authorize Grants Manager, Mary Witkofski, to submit an application and the necessary paperwork to the Arizona

Department of Transportation for the transportation enhancement funds set forth by the Federal Transportation Equity Act for the 21st Century on behalf of the City of Maricopa, Arizona.

That the City of Maricopa, Arizona hereby assures the Arizona Department of Transportation that sufficient funding for project overrun fees and the operation and maintenance of the SR 347 from Edison Road (MP 174) to Entrance of Fry's Market Place, Maricopa and DR 347 Monument Entry Feature at MP 173, Maricopa will be available for the life of the project.

That Brenda Fischer, City Manager of the City of Maricopa, Arizona, is authorized to sign the applications to the Arizona Department of Transportation for transportation enhancement program funds set forth by the Federal Transportation Equity Act for the 21st Century on behalf of the City of Maricopa, Arizona.
