My current concerns are an overpass at Riggs Road, a re-paving and widening of Casa Grande Highway such as what has been done just outside of Casa Grande, a 347 extension to I-8, and even a commuter train to Phoenix. With our constant population growth in Maricopa, we need to plan and put in place systems to alleviate traffic congestion and reduce traffic accidents in the immediate area as well as plan for alternate transportation methods.
