#### 1. Call to Order

*The City Council regular meeting was called to order at 7:05 pm. Maricopa Springs Family Church Pastor, Grady Root gave the invocation and Councilmember Wade led the Pledge of Allegiance.*

#### 3. Proclamations, Acknowledgements and Awards

*There were no items presented.*

#### 4. Report from the Mayor

*Councilmember Marsh stated he was tired or wearing mask and social distancing and urged everyone to get vaccinated. He reported attending the following: Planning and Zoning Commission meeting (P&Z), Age-Friendly Advisory Committee meeting, a morning scoop, a Parks, Recreation and Library (PRL) Committee meeting, a Council of Foreign Relations update, a Cultural Affairs Committee meeting, a Board of Adjustments meeting, a Maricopa Flood Control District meeting, a legislative update, and a Pinal County Board meeting. He elaborated on the Pinal County Board.*

*Councilmember Smith invited the public to attend Friday's Lunch and Learn at the Library at 11 a.m. and elaborated on the speakers and themes. Next, she reminded the community that on Saturday, the Senior Info/Expo would be held from 10 am to 2 pm at Copper Sky. Lastly, she stated that free Covid-19 tests were available at covidtests.gov.*

*Councilmember Wade gave a statement in observance of Martin Luther King Jr. Day.*

*Councilmember Vitiello reported on the balloon festival, Copa Glow and thanked city staff and the fire and police departments. He commended the event.*

*Mayor Price wished everyone a happy new year. He stated that on Friday, he would be*

*participating in a panel of mayors from Pinal County hosted by the Pinal Partnership and elaborated. Next, he reported attending the Arizona Department of Transportation (ADOT) meeting in the City of Globe in December and stated the next meeting would be held in Yuma and elaborated on the new members of the board. He elaborated on his discussion with ADOT Director John Halikowski and the process of road fixtures. He announced that Goodyear Mayor, Georgia Lord passed away and stated there would be a virtual service in her honor. He directed those interested to the City of Goodyear's webpage. Lastly, he invited Intergovernmental Affairs Director, Dale Wiebusch to make an announcement. Mr. Wiebusch announced that he would be leaving his employment with the City of Maricopa and that he had accepted a job offer from the City of Scottsdale. He thanked everyone and stated it was his pleasure and honor to work for the City.*

*Jessica Jantz stated she disagreed with Councilmember Marsh's statements made to InMaricopa back in September, 2021 regarding vaccine mandates. She elaborated on her concerns and personal beliefs. Councilmember Marsh clarified that vaccine mandates were out of his authority and that he had softened his stand on vaccine mandates since September.*

## 8. Regular Agenda and/or Public Hearings

- 8.1 [PH 22-01](#) The Mayor and City Council shall hear public comment regarding the Report on Applying Agreed-Upon Procedures Biennial Certification of Land Use Assumptions, Infrastructure Improvement Plan and Development Impact Fees for the July 1, 2018 through June 30, 2020.

*Budget Manager, Brenda Hasler gave a PowerPoint presentation on Development Impact Fees Biennial Audit. She gave background on SB 1525 that enabled cities to impose development fees and stated that in 2013 City decided on a biennial audit and elaborated on procedures. The public hearing was opened at 7:33 pm, there were no public comments and the hearing was closed at 7:33 pm*

**The Public Hearing was held.**

- 8.2 [PRES 22-01](#) The Mayor and City Council shall hear a 2021 Crime Report presentation from Police Chief James Hughes. Discussion only.

*Maricopa Police Department (MPD) Chief James Hughes presented the 2021 Crime Report. He discussed calls for service, violent crimes and how MPD was addressing it, including violence awareness, educational material and public service announcements (PSA). He discussed property crime and how it was addressed including increased patrols of construction sites, a dedicated property crime detective, crime prevention strategies, technology, and intelligence led policing. He explained what Part 2 crimes entailed and elaborated. He detailed the shift from the Uniform Crime Reporting (UCR) Program to the National Incident-Based Reporting System (NIBRS). He stated it was a federal mandate and explained NIBRS would be more comprehensive. He discussed traffic related activities and how they were addressed including greater presence, and higher percentage of warnings. He discussed use of force, demographics, police pursuits and department vehicle collisions. He concluded with statistics.*

*Councilmember Vitiello asked if there was a breakdown for DUI's incident involving alcohol and marijuana. Chief Hughes elaborated. Mayor Price asked if most cities were transitioning to NIBRS. Chief Hughes stated it was a federal mandate and elaborated. Councilmember Liermann commended the statistics and thanked MPD.*

*Councilmember Wade asked if there was an increase in workload in transitioning to NIBRS. Chief Hughes explained further. Mayor Price thanked Chief Hughes for the presentation and gave a brief statement on the perception that a growing city meant higher crime. City Manager Horst commented reiterated on population growth and stated that other variables, such as COVID-19, had to be considered as well.*

**The Presentation was heard.**

- 8.3 [PRES 22-02](#) The Mayor and City Council shall hear a presentation by Adam Saks, Executive Director of the Maricopa Economic Development Alliance. Discussion only.

*Adam Saks, Executive Director of the Maricopa Economic Development Alliance (MEDA) gave a six-month progress report presentation with highlights from Fiscal Year*

(FY) 2021-2022. He reviewed their objective and detailed prospect activity. He reported having a meeting earlier with prospective site selectors and elaborated on other activity. He discussed the promotion and marketing of Maricopa as a prime business location.

Councilmember Wade inquired about the reported city rankings. Mr. Saks elaborated. City Manager Horst thanked Mr. Saks and Community Services Director, Nathan Ulliyot and Mayor Price for hosting an international prospect group earlier today. He elaborated. A brief discussion ensued.

Councilmember Vitiello asked for an update on the virtual goggle tour. Mr. Saks elaborated.

**The Presentation was heard.**
