Dear Mayor Price and City Council Members:

Our office currently enjoys the opportunity to represent the City of Maricopa and would be pleased to continue our representation and association with the City of Maricopa at the pleasure of the City Council.

During our representation, we will have an attorney located in City Hall for two days a week, which will currently be on Monday and Wednesday. The attorney will be available to primarily work on civil matters during that time. Rather than have this attorney fill out daily timesheets, the City will pay our firm a monthly flat fee for this attorney's services, which will be invoiced separately.

All other duties, as set forth in Section 3-63 of the City Code, including, but not be limited to, attending the City Council meetings, Planning and Zoning Commission meetings, general civil work, and City Court prosecutions will be billed at an hourly rate. As we have done in the past, we will submit monthly bills to the City of Maricopa, which will include any costs incurred on behalf of the City of Maricopa.

For the 2019 – 2020 fiscal year, the rates for Fitzgibbons Law Offices, P.L.C. will remain the same as last year: a monthly flat fee of \$5,25.00, all civil matters will be billed at the rate of \$155.00 per hour, and all criminal matters will be billed at the rate of \$135.00 per hour. The rates for our representation and services in future fiscal years will be determined as part of the City's annual budget process until the term of our representation ends.
