- 10.1** [RES 20-51](#) A Resolution of the Mayor and City Council of the City of Maricopa, Arizona authorizing the waiver of the four-year advance notice of abandonment and pavement quality report required by A.R.S. §28-7209 to allow the State of Arizona, by and through the Department of Transportation, to abandon its interest in and to certain right of way located at the south end of the old Maricopa Road/State Route 347 alignment to the City of Maricopa and authorizing the City Manager to execute any additional documents related to such waiver. - 10.2** [GRAAC 20-04](#) The Mayor and City Council shall hear and possibly take action to accept a grant award in the amount of \$64,000 from Ak-Chin Indian Community and enter into an Intergovernmental Agreement (IGA) between the City of Maricopa and Ak-Chin Indian

Community. There is no matching requirement. Discussion and Action.

This Memorandum of Understanding was Approved.

- 10.4 [CON 20-19](#) The Mayor and City Council shall discuss and possibly take action to ratify a Purchase and Sale Agreement and Escrow Instructions with Urban Storage Maricopa, LLC for the sale of 10.19 acres generally located at the Southeast corner of Edison Road and Estrella Gin Business Parkway, commonly known as the Estrella Gin Business Park, for \$1,331,629.00 Discussion and Action.

This Contract was Approved.

- 10.5 [CON 20-20](#) The Mayor and City Council shall discuss and possibly take action to ratify a Purchase and Sale Agreement and Escrow Instructions with Urban Storage Maricopa, LLC for the purchase approximately 4.18 acres of real property generally located on the Northeast corner of N Maricopa Road and Honeycutt Ave., for an approximate purchase price of \$2,093,920.00. Discussion and Action.

11. Regular Agenda and/or Public Hearings

- 11.1 [ORD 20-19](#) An Ordinance of the Mayor and City Council of the City of Maricopa, Arizona, amending the zoning requirements as described in Zoning Case Planned Area Development (PAD) 20-05 for the Stonegate PAD which is approximately 54 acres generally situated on the northwest corner of Alan Stephens Parkway and Stonegate Road within the City of Maricopa incorporated limits. The parcels of land are situated in a portion of Section 35 and 36 of Township 4 South, Range 3 East of the Gila and Salt River Base and Meridian, Pinal County, Arizona. Discussion and Action.

Mayor Price read the Ordinance. Economic and Community Development, Deputy Director, Rodolfo Lopez gave a PowerPoint presentation on the Zoning Case Planned Area Development, PAD 20-05. He provided site information including visuals of the site location, and the General Plan. He discussed the existing PAD and the request. He presented a Concept Development Plan, the Bike and Pedestrian Plan, the Open Space Concept, the Concept Street Sign and the Concept Phasing Plan. He discussed the Design Guidelines and detailed the Public Comments Outreach. He stated the required finding concluded that the amendment was consistent with the General Plan, the Subdivision Ordinance and any applicable master plans. He stated, that on November 9, 2020 the Planning and Zoning Commission recommended approval of PAD 20-05 subject to the conditions of approval stated in the staff report and as amended by the commission. He opened the floor for questions.

Vice Mayor Smith commended the builder for listening to the community and making

changes that acknowledged any concerns. She asked for clarification on the visibility and distance restrictions. City Manager Horst clarified.

A motion was made by Vice Mayor Smith, seconded by Councilmember Marsh, that this Ordinance be Approved. The motion carried by a unanimous vote.

11.2 **PRES 20-11**

The Mayor and City Council shall hear a presentation regarding an update on Heritage District Enhancements and other Neighborhood Services accomplishments from the past year.

Economic and Community Development director, Nathan Steele introduced Neighborhood Services Manager, Judy Ramos. Mrs. Ramos gave a PowerPoint Presentation. She gave a brief background of the Redevelopment District Area Plan (RDA), the established Design Guidelines, and the District Overlay. She discussed the coordinated Code Compliance efforts and provided photos. She provided photos of the Mainstreet upgrades, the Heritage District Fencing, the Solar Streetlight Project and Housing Rehabilitation. She opened the floor for questions.

Councilmember Wade asked why it was referred to as the RDA as opposed to the Heritage District. Mrs. Ramos and Mr. Steele elaborated. Discussion ensued. Next, Councilmember Wade asked about an alternate access point for the Veteran Center. City Manager Horst elaborated on future plans for added access.

Councilmember Vitiello thanked Mike Riggs and his staff. Mr. Steele gave a brief statement of future development and projects in the area. Mayor Price gave a brief statement.

The Presentation was heard.

11.3 **MISC 20-28**

The Mayor and City Council shall discuss the selection of a Vice-Mayor from among the members of the City Council pursuant to Maricopa City Code Section 2.05.090. Discussion and Action.

Councilmember Manfredi nominated Nancy Smith to continue as Vice Mayor. Councilmember Marsh commended Vice Mayor Smith.

A motion was made by Councilmember Manfredi, seconded by Councilmember Liermann, that this Miscellaneous Item be Approved. The motion carried by a unanimous vote.
