1. Call to Order

The City Council work session was called to order at 6:04 p.m.

2. Roll Call

3. Agenda Items

3.1 WS 15-01 The Mayor and City Council shall review items on the Regular City Council meeting agenda.

Mayor Price pulled items 9.4 and 9.6 from the consent section on the regular meeting agenda per Councilmember Smith's request.

3.2 WS 15-02 The Mayor and City Council shall hear reports on meeting and/or conferences attended by Council.

Vice Mayor Brown reported joining Mayors Tom Rankin of Florence, Jon Thompson of Coolidge, and Vice Mayor Micah Powell of Eloy at the Pinal County Partnership Breakfast. Next, he reported attending the 8th annual Arizona Muslim Police Appreciation Dinner on Saturday. He noted that Maricopa Police Chief Stahl was a key speaker and concluded by commending the event.

3.3 WSPRES 15-20 The Mayor and City Council shall hear an update presentation by Dan Marum, consultant for the Area Transportation Plan (ATP) on various project subcomponents, and next steps toward completion of Phase I of the ATP.

Transportation/Transit Planner David Maestas introduced project consultant, Dan Marum. Mr. Marum gave a presentation on the Area Transportation Plan (ATP) and its subcomponents. He discussed the Transportation Mater Plan (TMP) study progress including complete streets and trails. He detailed Transit Priorities for the years 2020, 2030, and 2040. Next he discussed the City's vision for an Intelligent Transportation System (ITS). He stated the city's ITS would monitor and optimize

traffic flow on arterial streets. He reviewed the recommendations and detailed ITS deployment scenarios. He detailed the implementation prioritization for the years 2020, 2030 and 2040. He detailed alternative network results for 2040 and build-out network deficiencies.

Vice Mayor Brown inquired about the East-West Corridor. Mr. Marum responded that other areas that Farrell Road could possibly require revision if the 347 overpass is built. Councilmember Wade stated that other areas play a part on the 347 overpass besides connectivity, such as safety. Discussion ensued.

Mr. Marum continued the presentation with a review of build-out network deficiencies identified on the SR 347, SR 238, East-West Corridor, White & Parker Road, Anderson Parkway, and the Val Vista/Miller Road Corridor. He commended the partnership with the Maricopa Association of Governments (MAG). He discussed potential modification to the Hidden Valley Framework Study and gave a summary of the study's outreach. He detailed the feedback received from MAG and the developer representing Santa Cruz Ranch. He noted all feedback would be included in the administrative record. He discussed the objective of the Regional Connectivity Plan and reviewed the next steps. He concluded by opening the floor for questions.

Mayor Price thanked Mr. Marum and commended the presentation. Vice Mayor Brown commended the support received from MAG. Mr. Marum concurred and elaborated on MAG's involvement.

The Presentation was heard.

4. Executive Session

5. Adjournment

The City Council work session was adjourned at 6:48 p.m.
