1. Call to Order

The City Council Regular Meeting was called to order at 7:10 p.m. Pastor Roger Thompson from Cavalry Chapel gave the invocation and Councilmember Vitiello led the Pledge of Allegiance.

2. Roll Call

3. Proclamations, Acknowledgements and Awards

3.1 [PROC 21-06](#) Veteran's Day Proclamation

Mayor Price invited all veterans who have served to the front to accept the proclamation. He read the proclamation and proclaimed November 11th of 2021 as Veteran's Day in the City of Maricopa.

Councilmember Vitiello gave information on the 5th Annual Izzy Calderon Softball Tournament.

Councilmember Wade thanked those who took the time to read the Maricopa Unified School District (MUSD) Override and voted on the issue. He thanked the Council for supporting the override.

Mayor Price thanked those who participated in the State of the City Address and thanked the sponsors. He stated that former representative Brett Roberts resigned and that he Pinal County Board of Supervisors selected Teresa Martinez as his replacement. He gave information on the veteran's parade on Saturday, November 6th at 9 a.m.

A motion was made by Councilmember Amber Liermann, seconded by Councilmember Rich Vitiello, to Adopt the Consent Agenda except Agenda Item 7.7 which was moved to the Regular Agenda. The motion carried by unanimous vote.

- 7.1 [SUB21-15](#) The Mayor and City Council shall discuss and take action to approve a final plat for Lakes at Rancho El Dorado, Parcel 55, residential subdivision, case #SUB21-15. Discussion and Action.

This Subdivision was Approved.

- 7.2 [CON 21-27](#) The Mayor and City Council shall discuss and take action to approve the Purchase and Sale Agreement and Escrow Instructions with ADOT, Arizona Department of Transportation, to purchase approximately .796 acres of Real Property located at 19563 N Maricopa Rd for \$260,000.00 and authorizing the City Manager to execute any extensions and closing documents related thereto. Discussion and Action.

Porter Road and W. Applegate Road, just north of Maricopa-Casa Grande Highway, within the City of Maricopa incorporated limits, as described in case # GPA 21-05. The land is situated in a portion of Section 36, Township 4 South, Range 3 East, Gila and Salt River Meridian, Pinal County, Arizona. Discussion and Action.

- 7.6 [ORD 21-19](#) An Ordinance of the Mayor and City Council of the City of Maricopa, Arizona, deleting Section 2.15.130(A)(2)(b) of the Maricopa City Code to eliminate the Merit Board as a Council established standing board and amending Section 3.75.060(J) of the Maricopa City Code to eliminate the ability to refer the administration of any election held pursuant to the Meet and Confer Code to the Chairperson of the Merit Board. Discussion and Action.

7.7 [ORD 21-20](#)

An Ordinance of the Mayor and City Council of the City of Maricopa, Arizona, approving and adopting an amendment to the City's Zoning Map to rezone approximately 13 acres of land generally located at the southeast corner of N. Porter Road and W. Applegate Road, just north of Maricopa-Casa Grande Highway, within the City of Maricopa incorporated limits, from Light Industry & Warehouse (CI-1) to General Mixed Use (MU-G) as described in Zoning Case #ZON21-03, for . The parcel of land is located in a portion of Section 36, Township 4 South, Range 3 East, Gila and Salt River Meridian, Pinal County, Arizona. Discussion and Action.

Mr. Robert Klob submitted a speaker card and stated he was a recent Maricopa resident. He described his professional experience in site-plan design and as a commissioner in the Chandler Planning and Zoning Commission. He detailed his concerns with the proposed multi-family aspect of the planned development including access, removing the current stop sign that exists in Porter Road and possible conflicts with traffic flow.

Rodolfo Lopez, Director of the Development Services Department explained that the item tonight was to approve rezoning from Light Industry & Warehouse (CI-1) to General Mixed Use (MU-G) and the actual site-plan design would be brought back for approval and there would be opportunity before that for public input. He addressed Mr. Klob's concerns with access. City Manager Horst stated he met with the Land Commissioner last week about all state land in the City and elaborated. He stated that the developers in the retail were excited about having the rooftops and elaborated. He stated one of the problems in the City was that some of the land still fell under County zoning and elaborated. He elaborated on the storm drainage and reiterated that tonight would approve a land use rezoning only.

Mayor Price discussed economic growth and its role in the quality of life. He gave brief statement on why growth was beneficial. He stated he was hopeful on the mixed use component of the planned development. Councilmember Vitiello encouraged Mr. Klob to attend the Planning & Zoning Commission meetings.

A motion was made by Councilmember Marsh, seconded by Councilmember Wade, that this Ordinance be Approved. The motion carried by a unanimous vote.

8.1 [PRES 21-23](#)

The Mayor and City Council shall hear a presentation from City Manager Horst on cemetery possibilities within the city. Discussion only.

City Manager Horst gave a PowerPoint presentation on cemetery possibilities. He discussed the Peed property (11.34 acres) owned since 2006. He provided a visual aerial of the site. He stated property around it was recently sold for residential community. He provided a visual of the two properties. He discussed concept designs.

Councilmember Vitiello asked how many residents would fit. City Manager Horst responded and added one acre would be possibly held for a mortuary.

Vice Mayor Smith asked about the management of the property. City Manager Horst stated bids could go out for bids and elaborated. He recommended creating trust for long term maintenance.

Councilmember Wade asked for clarification on the location.

Mayor Price spoke in favor of the cemetery and stated he would like to think more about the conceptual designs and so on.

Councilmember Marsh urged to move forward. Consensus was to move forward with exploring the possibilities of a city cemetery.

The Presentation was heard.

9. Executive Session

A motion was made by Vice Mayor Nancy Smith, seconded by Councilmember Henry Wade, to go in to Executive Session at 8:14 p.m. The motion carried unanimously.

9.1 ES 21-29

The Maricopa City Council may go into executive session for the purpose of discussion or consultation with the City Attorney and designated representatives of the City in order to consider its position and instruct its representatives regarding emergency management services including, but not limited to, the addition of ambulatory services, storm risk and event management, pre and post event management, utility outages, protocols and necessary infrastructure for current and future growth related thereto; and legal advice regarding the same, pursuant to A.R.S. §38-431.03(A)(1), (A)(3) and (A)(4).
