## 5.1 <u>DRP 24-10</u>

PLANNING COMMISSION UPDATE: Major Development Review Permit case # DRP24-10 O'Reilly Auto Parts, a request by O'Reilly Auto Enterprises, LLC, for review of Site, Floor, Elevation, Landscape and Photometric Plans for a proposed auto parts store on approximately 0.705-acres of land within the City of Maricopa, generally located west of the northwest corner of W. Maricopa-Casa Grande Hwy., and N. Shea Way. DISCUSSION ONLY.

Commissioner Thomas asked if there were currently businesses located on the property mentioned and LaRee did state that it was a vacant lot, no businesses are there yet.
