#### 1. Call to Order

The City Council regular meeting was called to order at 7:18 p.m.

Councilmember Wade gave the invocation.

Councilmember Manfredi led the meeting attendees in the Pledge of Allegiance.

# 3. Proclamations, Acknowledgements and Awards

The Maricopa Lady Rams basketball team was acknowledged for winning their first State Championship. The Maricopa High School band opened with a brief number and then Mayor Price invited the school principal and the team to the front. Councilmember Wade commended the team, then the Council presented them with a plaque and medals of recognition. The team posed for pictures with the Council and Mayor Price invited them to a small reception in the lobby.

# 4. Report from the Mayor

Mayor Price reported traveling to Washington D.C. to attend the Annual National League of Cities and Towns Conference. He stated the conference is a great opportunity to lobby for issues pertaining to Maricopa. He reported on the activities during the trip including the opportunity to speak about the City of Maricopa during a presentation called Big Ideas, Small Cities and thanked other councilmembers for their support. He recognized Ak-Chin Chairman Manuel for flying out to Washington D.C. with intentions to attend a meeting that was eventually cancelled. Next, he recognized the Maricopa Wells Middle School's Future Cities Team for winning national awards. In conclusion he gave information on the Maricopa Stand-Up for Vets event hosted by Councilmember Bridger Kimball in conjunction with local Veteran organizations. He stated the event would take place, March 19th from 6 to 9 p.m. at Copper Sky Regional Park (44345 W. Martin Luther King Jr. Boulevard). He noted the event would feature a variety of Veteran services and encouraged

participation.

# 5. Report from the City Manager

City Manger Rose had no items to report.

### 6. Call to the Public

Dr. Gary Miller, member of the Maricopa Unified School District (MUSD) board, approached the podium and addressed the Mayor and Council. He stated that he was unable to participate in the 2040 Vision Strategic Plan due to the many roles he has. He pointed out that 'quality of life' is mentioned throughout the strategic plan and recommended defining the term. He provided the definition for quality of life from the World Health Organization. He acknowledged the participants of the 2040 Vision Strategic Planning and commended their work. He reiterated his recommendation to define quality of life and offered to send information to the Council.

Mayor Price directed him to contact Intergovernmental Affairs Director, Paul Jepson with any additional information.

Lee Pearce, with the Friends of the Library, approached the podium and addressed the Mayor and Council. She thanked the members of the council who participated in the Dr. Seuss Birthday event. Next, she announced that the Maricopa Public Library (MPL) has won the Bookapalooza grant from the Association of Library Services to Children (ALSC). She added that through the grant the library anticipates approximately 1,000 books, audio books, and DVD's for children. She read the statement from ALSC that explained that one of the reasons that MPL was awarded the grant was because the children's collection circulates at twice the national average. She emphasized the importance of investing in the library.

Scott Cole, representative of the Santa Cruz Ranch master plan community, approached the podium and addressed the Mayor and Council. He expressed concerns with the Transportation Master Plan presented during the work session earlier at 6 p.m. He stated that they have a development agreement with Pinal County that does not include the proposed parkways. He stated that the parkways would have a profound negative impact on their master plan and added that there are alternate alignments. He elaborated and asked that it be expeditiously determined whether the parkways would be a condition of annexation, and if not ,to expedite the process in order for them to meet deadlines.

LeeAnn Clark approached the podium and addressed the Mayor and Council. She stated that on March 7th the Maricopa Police Department (MPD) and Pinal County Attorney's office hosted a shredding event from 9 a.m. to 12 p.m. She stated the event was free but donations were accepted for the Maricopa food bank. She reported on the event and thanked the agencies and volunteers involved.

Paul Beck approached the podium and addressed the Mayor and Council. He stated that he and his wife are part time residents. He spoke on behalf of the Friends of the Library and commended the community for participating in the events and services the library offers. He stated that the award reflects back on the community.

Councilmember Chapados approached the podium and acknowledged that Mayor Price would be celebrating his 40th birthday on Friday. Mayor Price was presented with brownies and Vice Mayor Brown gave a few words in honor of his birthday.

Dave Bock approached the podium and addressed the Mayor and Council. He gave
