PURCHASING SUMMARY

Honeycutt Road Widening Project IFB 14DSD011414

In accordance with City of Maricopa, Purchasing Code, Article IV, Sec 3-215, the City issued a solicitation detailing requirements for the widening of approximately one mile of Honeycutt Road on the south of the centerline from Porter Road east to White and Parker Road.

Adequate public notice was given by placing the Invitation for Bid (IFB) on the City's web site, www.maricopa-az.gov, on January 23, 2014. Furthermore, in compliance with A.R.S. § 34-201 (A), an advertisement was placed in the Casa Grande Dispatch on the dates of January 30, 2014 and February 5, 2014.

In addition, a pre-bid Conference was held February 5, 2014 at the Maricopa City Hall. Two (2) amendments were posted on the City website: Amendment # 1 on February 12, 2014 and Amendment # 2 on February 14, 2014, along with the clarification Questions and Answers from the pre-bid meeting. The Invitation for Bids closed on February 20, 2014. The submitted proposals were publicly opened at the time and place designated within the IFB at the City Hall.

Twelve (12) responses to the IFB were received. The preliminary review conducted by the Purchasing Office of the submittals revealed the response from 1 firm to be a non-responsive bid. The following eleven (11) firms were responsive.
