

**ADDENDUM TO MASTER  
COMMUNICATIONS SYSTEM AGREEMENT**

THIS ADDENDUM TO AGREEMENT (“Addendum”) is made and entered into this 21<sup>st</sup> day of October, 2014, by and between the City of Maricopa, ARIZONA, an Arizona municipal corporation (“City”), and Motorola, Inc. (“Motorola”).

WHEREAS, City desires to purchase communications equipment, licensing software and communication systems; and

WHEREAS, Motorola is fully experienced and properly qualified, is in compliance with all applicable license requirements, and is organized and financed to provide the requisite services;

WHEREAS, in procuring this Work, City has complied with the cooperative purchasing procedures set forth in Section 3-223 of the City of Maricopa’s City Code; and

WHEREAS, the parties now desire to amend the Agreement known as Agreement No: 124391 entered into between the City of Phoenix and Motorola, Inc. (“Agreement”).

NOW, THEREFORE, City agrees to contract with Motorola and Motorola agrees to provide the products and services required according to the terms and conditions and for the consideration hereinafter set forth in the Agreement which shall be amended as follows:

1. All reference to “CITY” in the Agreement shall refer to the City of Maricopa, Arizona, an Arizona municipal corporation.
2. This Addendum and the Agreement as it applies to the City of Maricopa is effective as of the date first set forth above and shall expire upon completion of the purchases and services provided pursuant hereto, or the date the Agreement expires, whichever is earlier.
3. All references to Exhibits 1-8 in the Agreement shall refer to Exhibit 1, Scope of Work and Compensation, attached hereto and incorporated herein by reference.
4. Paragraphs 16.1(C) and (E) shall be revised to specify that any notice of insurance cancellation and certificates of insurance shall be sent to Gregory Rose, City Manager, 39700 West Civic Center Plaza South, Maricopa, AZ 85138.
5. Paragraph 17.9 of the Agreement, Notices, shall be revised to include the following for notice to the City:

6. All other terms and conditions of the Agreement are to continue in full force and effect as stated and agreed to in the Agreement.
