Background

- Non-Profit Scholarship Program
 - Provides matching funds to local non-profits to increase size or number of scholarships awarded to local students
 - \$10,000 set aside in FY16-17 City Budget
 - GL Account: 10010000-53340



Last Year

- Funded Two (2) Organizations
 - Maricopa Chamber of Commerce
 - \$3,000
 - Friends of the Library
 - \$2,000



Recommendations

- Registering Non-Profits
- Request for Proposal
- Application
- Scoring/Evaluation



Registering Non-Profits

- Require Non-Profits to fill out business license application
 - No or Nominal Fee for Non-Profits
 - Other Cities already do this
 - Enables better communication and resource sharing with Non-Profit community
 - eCivis, Scholarship Match, Grant Partnerships, other



Request For Proposal

- Organization Eligibility

- NEW Bullets

- Must have Business License (pending approval)
 - Must Submit Letter of Commitment

- Language Updated

- Must provide evidence .. can financially match funds before funds are released
 - If previous recipient, must be current on reporting on previous funds or ineligible this year



Request For Proposal ... cont

- Nature of Scholarship
 - All graduating high school students living within MUSD boundaries are eligible
 - Community Service is required
 - Scholarships of Non-Profits cannot mandate a program of study
 - Must be used for secondary/higher education opportunities beyond high school



Application

- Part II
 - Added
 - Anticipated # of Scholarships
 - Anticipated # of Scholarships utilizing City Match funds
 - Anticipated Size of Scholarships
 - Removed
 - Proof of Availability – part of Eligibility Criteria

Application ... cont.

- Part III
 - Organization Compliance Documents
 - Updated language
 - IRS 501(c) Letter
 - Current Listing of Board of Directors
 - Added
 - Letter of Commitment from Organization (NEW)
 - Removed
 - Letter of Agreement (this will happen at time of fund disbursement)



Scoring/Evaluation

- Removed
 - Organization Eligibility
 - Nature of Scholarship
- This will be done upfront by Grant Coordinator for City. This will allow NPE Committee to focus on the merits of the applications versus checking eligibility requirements.



Scoring/Evaluation ... cont.

- Removed
 - #1: Is the applicant 501 (c)?
 - #5: Do scholarships(s) mandate program of study?
 - #7: Is scholarship(s) limited to students living within MUSD boundaries?
 - These items will be checked by Grants Coordinator (City)

Scoring/Evaluation ... cont.

- 100 points total
 - 25 points per question
 - Eliminated redundant questions
 - Eases process to review each application
