#### 1. Call to Order

The City Council regular meeting was called to order at 7:04 p.m.

Pastor Glenn Zimbleman, from the Maricopa Lutheran Church, gave the invocation.

Councilmember Kimball led the meeting attendees in the Pledge of Allegiance.

#### 4. Report from the Mayor

Mayor Price reported attending a Firefighter's Convention in Washington D.C. and added he took the opportunity to visit with Congresswoman Kirkpatrick, Congressman Gosar, Senator Flake, and Senator McCain. He highlighted that Senator McCain agreed to sign unto the Tiger Grant Request Letter and emphasized the importance of networking. Next, he reported on the joint meeting with the 2040 Vision Steering Committee and thanked the participants for their work.

Mayor Price invited Police Chief Stahl to the front and announced that the Maricopa Police Department was awarded accreditation by the Commission on Accreditation for Law Enforcement Agencies (CALEA). Chief Stahl stated that the accreditation allows the department to follow the best-practices according to nationwide standards. He briefly explained the process of attaining accreditation. He noted it is a voluntary accreditation and while it has no direct financial benefits, it helps when applying for grants. He thanked Mayor Price and the members of the Council, present and past. He thanked City Manager Rose, the police officers, and the staff involved. He gave special thanks to Police Administrative Assistant Tim Gomez, and Police Officer Jenny Alcidez. He added that he is not satisfied and that in 3 years they will pursue the gold standard award. Mayor Price congratulated the police department.

#### 5. Report from the City Manager

City Manager Rose announced that Economic Development Specialist Denyse Airheart would be assuming the role of Interim Economic Development Director.

Councilmember Henry Wade approached the podium and addressed the Mayor and Council. He invited Lee Anne Clark to join him and reported attending the Maricopa High School prom dress fashion show. He and Mrs. Clark commended the youth who participated in the event.
