### 3.1 RES 24-43

A Resolution of the Mayor and City Council of the City of Maricopa, Arizona, declaring and adopting the results of the Primary Election held on July 30, 2024. Discussion and Action.

City Clerk Vanessa Bueras gave a brief presentation on the election results. She stated the total ballots cast for the office of Mayor and Councilmember were 9,527 and in order to be elected at the Primary, candidates needed to receive a majority of the votes cast. She stated state statue defined that calculation. She announced the following received the necessary number of votes to be elected at the Primary and would be issued certificates of election:

Mayor:

Nancy Smith with 5,546 votes.

Councilmember:

Eric Goettl with 4,916 votes Amber Liermann with 5,602 votes Bob Marsh with 4,824 votes

She added that Proposition 482, a land sale proposition, was approved by the voters with the following vote:

Yes: 4,854 No: 3,892

Councilmember Wade congratulated those elected. Councilmember Marsh stated he

has celebrated since election day that they get to keep the band together.

Coucilmember Goettl commended City Clerk Bueras and her team. Councilmember

Knorr congratulated everyone and commended the community's support for Proposition
482. Councilmember Goettl asked the City Clerk if she received any comments or

concerns from the community. Mrs. Bueras responded she did not receive any

comments or concerns.

A motion was made by Councilmember Wade, seconded by Councilmember Manfredi that this resolution be approved. The Resolution was Approved by unanimous vote.
