# Project Narrative

## The Trails at Tortosa

The Trails at Tortosa (“Project”) is located in the City of Maricopa, Arizona, at the NW intersection of Murphy Rd and Honeycutt Boulevard. The current preliminary plat submittal outlines the design of this single-family residential community, which includes 287 acres and the development of 1,052 lots within 12 parcels. The lot sizes will include the following:

60’ x 120’ – 278 lots

50’ x 120’ – 261 lots

45’ x 120’ – 287 lots

55’ x 120’ – 226 lots

The community will be constructed in four phases. It is expected that phase 1A will be constructed first and the others, 1B, 2 and 3, will follow chronologically as the Project is sold to builders and final plat and final engineering plans for each phase are approved by the City of Maricopa.

The Trails at Tortosa will have its own Homeowners Association to maintain many of the amenities that will be offered. Although tentative at this time, the below features/amenities are anticipated:

- 1) Enhanced project announcement and entry feature at the intersection of Honeycutt Road and the Costa Del Sol Boulevard.
- 2) Dedicated space for a reclaimed irrigation water feature in the interior of the Project.
- 3) Enhanced paving treatment and landscape median at the entrance of Costa Del Sol Boulevard.
- 4) A pedestrian loop trail and neighborhood trail system that will connect the open space and community spaces within and around the overall Tortosa community.

Currently, the third phase of this Project is located in a FEMA designated flood zone. In an effort to remove this designation, a Conditional Letter of Map Revision (“CLOMR”) will be submitted to FEMA, which includes drainage improvements to the existing channel. These improvements will eliminate a flooding event and hopefully result in a new designation out of the flood zone.

The water, wastewater, and reclaimed water services will be provided by Global Water. Public sewer, water and reclaimed water infrastructure currently exists adjacent to the Property with adequate capacity to serve The Trails at Tortosa community.





# Minutes

## The Trails at Tortosa

### Neighborhood Meeting

January 10, 2016 @6pm

**Call to order** – Mike Kern called the meeting to order at 6pm.

**Introductions** – Mike Kern introduced himself as President of Communities Southwest, Stefanie Crerie as Project Manager for Communities Southwest, and Michelle Yerger as Senior Project Manager for Communities Southwest.

**Content:** Mike Kern presented information about the proposed development called The Trails at Tortosa. A brief overview of the lot count, amenities, and phasing was discussed as depicted in the preliminary plat submittal.

**Questions:** There were many questions from the audience, which are described below:

1. What is Communities Southwest? Michael Kern explained it is a land investment company. The company buys raw land and entitles it to sell to builders. It has multiple projects around the valley and, in the past, had projects in California.
2. Who builds the homes? Communities Southwest does not build the homes. The company sells “paper lots” to a builder who would construct the homes.
3. Who will construct another exit road besides Honeycutt so we can get out of the community in case of an emergency? There was a traffic study done to prepare for this development which evaluated the planned traffic flow for this community.
4. Will Hartman be improved with this project? No. We are only responsible for adjacent roadway improvements. The City will manage infrastructure improvements over time as development returns to the area. Additional rooftops and a larger tax base is necessary to justify certain infrastructure improvements.
5. What is the purpose of this meeting? The purpose is for residents to provide involvement and input in the events of their neighborhood.

6. When will construction begin? Construction will start when the market demand is back. It is thought this will be within the next few years. Already there is renewed interest in development in the City of Maricopa.
7. What if there is too much lot competition and no one buys your lots? We typically sell the land with paper lots and the builder improves the lots. Regarding The Trails at Tortosa, Communities Southwest may end up improving the lots first and then selling them so it's easier for a builder to start construction right away. Communities Southwest does not anticipate leaving vacant lots to sit for a long period of time because the general understanding is that the market is getting stronger.
8. Do you have a builder to sell to now? No, not at this time.
9. What do we need to do to have a Circle K in Tortosa? What about a mall? There is commercial zoning outside the Tortosa HOA. Commercial properties are constructed when there are enough residents to support the business so it may take a while for commercial to come in.
10. We want an exit route from the new development directly to Murphy so there is direct access to Casa Grande Highway. We are improving the portion of Murphy Road adjacent to the project but there are no plans to construct direct access to Murphy. Residents desiring to travel west will still take Honeycutt to exit the community rather than traveling south to the Casa Grande Highway.
11. Can we use your HOA amenities? No, only the residents of The Trails at Tortosa can use those amenities because they will pay to maintain them.
12. Will it be gated? No, not planning on it.
13. Has the city approved it? No, we just submitted the preliminary plat for approval.
14. We have an over-supply of lots and no demand, which will lower our current house prices and there is not enough city infrastructure. What do you think? All towns experience growing pains and it is a process, which will be fixed over time. We think the demand is coming since the market has picked up.
15. Will you follow dust control? Yes, we are required to and will place a sign on the property with contact info should there be an issue.

16. We want something in place not to allow spec homes since there were so many left vacant from back when the market crashed. Can you do this? We do not want to put measures in place that will make it difficult for our buyers. Spec homes are a big expense/liability so builders are cautious about this.
17. What type of amenities will be there? Communities Southwest is still reviewing options and costs to find the best amenities for The Trails at Tortosa. Nothing is definite at this time but we plan to have trails and open space.
18. What is the impact on schools? A study was not conducted to confirm current capacity. Comments from the audience said the schools were below capacity so they did not think this was an issue.
19. When will building stop? We'd expect it to take 5-8 years to complete once started. Building should start within the next year or two.
20. What will you do about the bugs that will come in my home if construction starts? We do not believe you will experience an increase of bugs in your home.
21. Was there an impact on the floodplain? Communities Southwest is in the process of submitting a CLOMR to FEMA, which includes the improvements planned for construction to modify the flood plain. This will remove the area from the flood plain.
22. What other lots have you sold in Maricopa? Communities Southwest sold 398 lots in Glennwilde. The company does not own any other property in the City of Maricopa besides The Trails at Tortosa.
23. What is the plan for the northeastern portion of the property? Communities Southwest does not own this area. It's owned by a company that operates the tower. We will screen this area as the city determines appropriate.
