

1. Briefly describe your organization's history, mission and goals.

Founded in the heart of Arizona, Maricopa is a community rich in history and deeply rooted in the Sonoran Desert. Initially located at Maricopa Wells on the southern banks of the Gila River, the town served as a crucial oasis for 1800s immigrants journeying to California's gold fields. As a major stagecoach relay station, it played an essential role in the development of the Southwest, providing vital resources for travelers. By the late 19th century, Maricopa adapted to the changing times by moving locations to align with the burgeoning railroad industry, becoming a key junction for the Southern Pacific and Maricopa and Phoenix Railroads. This shift spurred economic growth and transformed local agriculture, with Maricopa eventually cultivating a diverse range of crops and supporting a robust cattle industry. Incorporated in 2003, Maricopa witnessed explosive population growth, reflecting its adaptability and appeal. Now bordering two Native American communities, the city honors this cultural heritage while continuing to embrace the pioneering spirit that has characterized its development. Today, Maricopa remains a testament to American ingenuity, offering a blend of historical richness and modern prosperity, making it an ideal place for both residents and businesses.

3. Describe the proposed project, objectives, and your plan to implement.

The Maricopa Police Department (MPD) is requesting funding for critical capital improvements to enhance public safety within the City of Maricopa. The project aims to procure two Polaris Side by Side off-road vehicles, two M30T drones, and a traffic enforcement motorcycle. These assets will improve MPD's operational capabilities, particularly in responding to emergencies in remote areas, enhancing traffic enforcement, and providing aerial surveillance for crime prevention and search-and-rescue operations.

Objectives:

1. Improve emergency response efficiency in off-road and hard-to-reach locations.
2. Enhance traffic enforcement to reduce roadway incidents and increase safety.
3. Strengthen MPD's aerial surveillance and monitoring capabilities for public events, crime prevention, and search-and-rescue missions.

Implementation Plan:

- **Phase 1 (Q2 2025):** Procurement of all requested equipment through vetted suppliers.
- **Phase 2 (Q3 2025):** Officer training on the operation of Polaris vehicles, M30T drones, and the motorcycle.
- **Phase 3 (Q4 2025 - Ongoing):** Deployment and integration into MPD's daily operations, with performance evaluation and periodic reviews.

4. Describe how the proposed project satisfies one or more of the priority funding areas identified by the Gila River Indian Community.

This project aligns with the **Public Safety** funding priority by equipping MPD with advanced tools to improve emergency response, traffic safety, and surveillance capabilities. The City of Maricopa, which borders the Gila River Indian Community, shares a commitment to protecting all residents, including those from tribal lands who may require law

enforcement assistance while traveling through or visiting the city. Enhanced public safety measures also contribute to crime deterrence, benefitting both Maricopa and neighboring communities.

5. Identify the needs/problems to be addressed, the target population and number of people to be served by the project.

The City of Maricopa has experienced significant growth in recent years, increasing the demand for law enforcement services. The city's expansion into rural areas has made emergency response more challenging due to difficult terrain and limited accessibility. Additionally, the increasing volume of traffic on major roadways requires enhanced enforcement measures to prevent accidents and reckless driving.

Target Population:

- 70,000+ Maricopa residents
- Visitors and commuters, including members of the Gila River Indian Community
- Local businesses and community stakeholders

Projected Impact:

- Improved law enforcement accessibility in remote locations
- Enhanced safety on city roadways
- Strengthened surveillance and emergency response for public events and crisis situations

This is a **new project** for the Maricopa Police Department. While GRIC has previously funded public safety initiatives in Maricopa, the specific capital improvements requested in this grant application have not been previously funded.

- **Oct 2025 - Dec 2025:** Procurement of all requested equipment
- **Jan 2026 - Feb 2026:** Officer training and certification for the new vehicles and drones

Yes, the Maricopa Police Department would prioritize critical equipment based on available funding. If partial funding is received, priority would be given to:

1. One Polaris Side by Side (\$40,489.61)
2. One M30T Drone (\$12,091.30)
3. One Traffic Motorcycle (\$34,040.15)

Partial funding would still significantly enhance MPD's ability to improve public safety.

MPD has an established budget for maintenance and operational costs associated with vehicles and equipment.

Following the grant period, the department will ensure the continued use and upkeep of the requested assets through:

- **Annual city budget allocations for maintenance and fuel**
- **Federal and state grant applications for additional enhancements**
- **Private-public partnerships for equipment upgrades and technology support**
