# **RISK PROFILE/PROJECT NEED**

#### Describe your understanding of the terrorism risk that your area faces.:

Sitting on the border of Phoenix metro area, terrorism is a major risk to the area. The City of Phoenix and other cities in the metro area host many high profile events like the Super Bowl and Waste Management Open on a regular basis that could be targets for terrorist activities. Also having the Palo Verde Power Plant to the west of Phoenix poses an additional terrorist threat. The fact that we are within 150 miles of the Mexico border adds to the

potential threats faced by the area. As a public safety department, we would support any efforts in the region that are caused by terrorism.

#### Describe your understanding of the natural hazards risk that your area faces. :

Drought, wildfires, tropical storms (severe wind), and flooding are the four major natural hazards that provide the greatest risk to the City. Due to the terrain and topography of the area, Maricopa is especially prone to flooding with a major portion of the City laying within a flood plain.

#### What assets and capabilities does your agency currently have that allows for addressing these risks?:

The City is in the process of completing its Emergency Operations Center that will be located within one of the MPD substations. This will improve our ability to mobilize and support efforts from a centralized location that has advanced technology to monitor and assist in the response efforts. We also have over 100 police and fire personnel trained in multiple specialties that will be able to assist. These individuals have communication, tactical, and operational equipment that can be deployed to assist as well.

#### How would this project help your agency address these risks?:

The additional radios will improve our communication and interoperability with other resources in the region. Better communication increases the ability of the City to respond and interact with agencies in times of emergency and need. The ability to communication with multiple agencies including the Feds, State, and other regional partners is essential in addressing these risks.

#### Describe why your agency needs this project to be funded.:

MPD and the City have been under tight fiscal constraints over the last few years due to the economic downturn. The City is also in the process of preparing for one of our major revenue streams disappearing in the next couple of years as the support from that funding source will no longer be available. Due to those two factors, MPD and the City have limited capacity to purpose all the equipment needed to be as efficient and effective as possible. The grant funds would aid MPD in procuring needed radios to increase our interoperability with our regional partners.

#### Describe how your agency will maintain this capability.:

Communication is a vital component of public safety and serving the needs of the community. MPD and the City are committed to providing its personnel the equipment needed to be operational to the best of our ability. At times this means tough decisions have to be made and while communication is vital so are other areas that need funds. So while their is commitment to sustain, the level at which it is sustained may not be optimal due to fiscal constraints.
