

**RESOLUTION NO. 20-38**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, PINAL COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 4, 2020.**

**WHEREAS**, the City of Maricopa, Pinal County, Arizona did hold a primary election on the 4<sup>th</sup> day of August, 2020 for the election of a Mayor and three Councilmembers for a 4-year term; and

**WHEREAS**, the election returns have been presented to and have been canvassed by the city council.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Maricopa, Pinal County, Arizona as follows:

**SECTION 1.** That the total number of ballots cast at said primary election, as shown by the poll lists, was 8,685.

**SECTION 2.** That the votes cast for the candidates for Mayor were as follows:

- Bob Marsh – Councilmember

**SECTION 5.** That it is hereby found, determined and declared of record, that the following two (2) candidates did receive the next greatest number of votes of the electors of the city voting at said election and shall have their names placed on the general municipal election ballot of the City of Maricopa, Pinal County, Arizona, to be held on the 3<sup>rd</sup> day of November, 2020, and are hereby issued certificates of nomination.
