This correspondence is in response to your request for financial advisory fee estimates related to acquiring a water utility. Under our existing agreement with the City, we receive compensation in one or a combination of ways including: (1) on a contingency basis from bond proceeds, (2) hourly fees for special services, and (3) special project compensation.

Based on our understanding of the initial services required, we can rely on a fixed amount for a special project as outlined below.

Project: Price Estimates for Water Utility Acquisition

Scope of Work: Collect, review, and analyze publicly available revenue and expense data. Estimate range of acquisition prices using common valuation methodologies. Compare findings to similar acquisitions. Document and present findings to City officials.

Timeline: Based on our understanding of the project and scope of work, we estimate it will require 3-4 weeks to complete the project once we are authorized to proceed.

Fee Estimate: Based on our understanding of the scope of work as outlined above, we propose a fee of \$15,000. This proposed fee includes out-of-pocket, travel, and miscellaneous fees in addition to the professional services required.

After completing the Price Estimates for Water Acquisition, we can propose additional fees to assist the City to: (1) negotiate the acquisition – with compensation based on hourly fees or a fixed special project fee with compensation either from fund balances or financing proceeds and (2) finance the acquisition – with compensation based on the financing amount and funded from proceeds of the financing.
