ORDINANCE NUMBER 16-13

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, ADOPTING "2016 AMENDMENTS TO CHAPTER 14 SUBDIVISION REGULATIONS" BY REFERENCE AND AMENDING CERTAIN PROVISIONS OF SECTIONS 14-1-6 THROUGH 14-7-3 OF THE MARICOPA CITY CODE AND PROVIDING FOR SEVERABILITY AND THE EFFECTIVE DATE THEREOF.

- **WHEREAS**, that certain document known as "2016 Amendments to Chapter 14 Subdivision Regulations" was adopted as a public record by Resolution 16-34 on November 1, 2016; and
- **WHEREAS**, on June 1, 2004, the City of Maricopa adopted the Pinal County Subdivision Regulations as its Subdivision Code; and
- **WHEREAS,** on February 1, 2005, the City of Maricopa adopted Ordinance 05-03 amending the Subdivision Code by amending the definition of Master Plan, inserting a definition for a planned area development and changing the duration that preliminary plats for planned area developments are effective; and
- **WHEREAS,** on November 30, 2006, the City of Maricopa adopted Ordinance 06-18 revising the City's Subdivision Code by replacing the Pinal County Subdivision Regulations with the City's own rules and regulations; and
- **WHEREAS**, the Mayor and City Council of the City of Maricopa believe, after consultation with its staff, that amending Chapter 14 of the Maricopa City Code would be in the best interest of the City of Maricopa; and
- **WHEREAS**, A.R.S. §9-802 allows a City to adopt a public record by Ordinance as a means to reduce publication costs while ensuring that the public gets fair notice and opportunity to review its operative provisions.
- **NOW, THEREFORE, BE IT ORDAINED** by the Mayor and City Council of the City of Maricopa, Arizona as follows:
- **SECTION 1.** Pursuant to Arizona Revised Statutes Section 9-802, that certain document known as "2016 Amendments to Chapter 14 Subdivision Regulations" of the Maricopa City Code, a copy of which is on file in the office of the City Clerk of the City of Maricopa, Arizona, which document was made a public record by Resolution 16-34 of the City of Maricopa, Arizona, is hereby referred to, adopted and made a part hereof as if fully set out in this Ordinance.
- **SECTION 2.** Sections 14-1-6 through 14-7-3 of the Maricopa City Code and all amendments thereto are hereby amended as set forth in the 2016 Amendments to Chapter 14

Subdivision Regulations which was made public record by Resolution 16-34 of the City of Maricopa, Arizona.

SECTION 3. To the extent of any conflict between other City Ordinances and this Ordinance, this Ordinance shall be deemed to be controlling; provided, however, that this Ordinance is not intended to amend or repeal any existing City Ordinance, Resolution or regulation except as expressly set forth herein.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

SECTION 5. This Ordinance shall become effective thirty (30) days from the date of adoption by the City Council for the City of Maricopa.
