RESOLUTION NO. 12-11

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF MARICOPA, ARIZONA, AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE GILA RIVER INDIAN COMMUNITY IN SUPPORT OF FUNDING FOR THE CITY OF MARICOPA REDEVELOPMENT DISTRICT COMMUNITY CLEAN-UP AND FAÇADE IMPROVEMENT PROGRAM.

WHEREAS, the Gila River Indian Community administers a grant program which provides Proposition 200 Indian Gaming funds to cities, towns and counties for government services that benefit the general public in the areas of public safety, transportation, health care, economic development and education; and

WHEREAS, the City of Maricopa encourages and supports improving quality of life in the community and encourages private investment and revitalization to the City's core; and

WHEREAS, the City of Maricopa has adopted a Redevelopment District Area plan that provides a 20-plus year guideline for revitalization of the 3.1 mile area; and

WHEREAS, the City of Maricopa Economic Development Department will prepare a grant application for submission to the Gila River Indian Community requesting funds to be used to complete a third Community Cleanup Initiative and implement a Façade Improvement Program to focus on property within the designated Redevelopment Area as defined in Resolution 08-48; and

NOW, THEREFORE, BE IT RESOLVED BY the Mayor and City Council of the City of Maricopa, Arizona as follows:

- 1. That the Maricopa City Council herby approves submission of an application for Gila River Indian Community State Shared Revenue Program funds in the amount of \$100,000.
- 2. That the Maricopa City Council herby authorizes staff to execute the grant application and transmit the application materials and supporting documentation as approved by the City of Maricopa Economic Development Department to the Gila River Indian Community.
- 3. That the City of Maricopa agrees to accept any grant funds awarded by the Gila River Indian Community pursuant to this application and upon receipt to transmit such funds to the Maricopa Finance Department for disbursement to the City of Maricopa Economic Development Department.

- 4. That the City's submission of the grant application and disbursement of any grant funds received by the City of Maricopa Economic Development Department is expressly conditioned on compliance with all appropriate procedures, guidelines and requirements of the grant including but not limited to financial disclosure and program related reports to the Gila River Indian Community.
- 5. That the Maricopa City Council, herby authorizes the City to submit a grant application to the Gila River Indian Community to be used to complete a Community Cleanup Initiative and implement a Façade Improvement Program.
