Grant Application Outline for Narrative

A. Purpose of Grant.

1. Describe the proposed program.

The Purpose of this Grant Application is to help provide the Maricopa High School Football Booster Program for camp fees, travel, meals, workout clothes, uniforms, equipment, banquets, concession stands, etc.

Football is an important activity in our community. The kids need to feel a part of a team and a sense of belonging. They learn teamwork and respect from this program. These are long-term life skills. We also teach kids to work out and nutrition skills. We teach them that they need to be on the Honor Roll and they need to be outstanding citizens. An outstanding successful football program brings notice to Maricopa. It helps bring and maintain students and families in Maricopa for our football program.

2. Identify the target population.

This grant would benefit 110 football players at Maricopa High School.

3. Describe the Project goals and objectives, and your plan to meet them.

Maricopa High School Football is dedicated to "Engineering Champions Forever." We strive for excellence both on and off the field by teaching these kids the value of accountability, respect, honesty, determination and perseverance. These are skills that we would like them to hone and practice so that we have done our part in making them a "champion" for years to come regardless of their endeavor.

The goals are to provide for the needs of players and help keep players in our community versus bussing out students to other schools. Our goal is to have a top football program that Maricopa is noticed for.

4. Provide a timetable for implementation of the Project.

The timetable for this Project is the 2018-2019 school year.

B. Resources.

The current funding source is from fundraisers such as selling MacDonald's cards, car washes, youth camps, etc. Also out-of-pocket costs for players for camp, etc. These fundraisers are ongoing throughout the school year.

Various business are solicited for donations. Restaurants are also solicited to help donate food before games.

3. Define the Project as a new or continuing project.

The MHS football program is a continuing project every school year. The continuation of the project will be through fund-raisers and out-of-pocket expenses.

- C. Reports. How will you account for and manage the funding if you are selected?

The MHS Booster Club has a Treasurer that will be accountable for functions in QuickBooks. I will also volunteer myself to keep a detailed record of all expenditures.

- D. Budget. Provide a detailed budget of how the funding will be used. Provide an estimated timeline for when the funds will be expended.

We estimate we need \$515 per player. Workout gear consisting of three shorts and three t-shirts is estimated \$8,500. Banquets would be \$2,712. The previous uniforms were \$13,000. Camp traveling is \$2,000. Meals before games were an estimated 10,000 last year.

The timeline for this expenditure is the 2018-2019 school year.

- E. Additional Information.

We want players to have college scholarship opportunities. A good football program keeps the kids in Maricopa versus being bused out to other schools.

Our goal is to provide what these kids need. We don't want any kids missing out on camp because they didn't have funds to attend. Skills are learned at camp as well an opportunity to be scouted. We don't want any players worrying about how they are going to pay for gear. For example, playing in cleats that they have outgrown that hurt their feet. We don't want any players working out or playing a game that are hungry or worrying about how they are going to pay for their next meal. We want to take financial stress away from these kids and give them great opportunities to succeed within Maricopa.
