FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT

THIS FIRST AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT ("First Amendment") is made and entered into this 16th day of December, 2014, by and between the City of Maricopa, Arizona, an Arizona municipal corporation ("City"), and EPS Group, Inc., an Arizona Corporation ("Consultant"), for professional engineering services for the Edison Road – SR 347 to SR 238 – Roadway Design Project ("Project").

WHEREAS, on April 15, 2014, the Maricopa City Council approved an Agreement with Consultant to provide professional engineering services for the project ("Agreement"); and

WHEREAS, in procuring these services City has complied with the cooperative purchasing procedures set forth in Section 3-223 of the City of Maricopa's City Code; and

WHEREAS, the parties now desire to amend the Agreement to expand the scope of work to include the extension of the 36" sewer in SR 238 and increase the not to exceed compensation amount for such expanded scope.

NOW, THEREFORE, the parties specifically agree to amend the Agreement approved on April 15, 2014 as follows:

1. Section 2 of the Agreement shall be amended to add the Scope of Work included in Exhibit 1, which is attached hereto and incorporated herein by reference.

2. Section 3 of the Agreement shall be amended to add the Cost of Work included in Exhibit 1, which is attached hereto and incorporated herein by reference.

In no event, shall the total compensation under the Agreement and this First Amendment exceed FOUR HUNDRED FOUR THOUSAND ONE HUNDRED SIXTY NINE and 00/100 Dollars (\$404,169.00) plus allowances as set forth in Exhibit C to the Agreement. Exhausting the total amount payable for activities described herein shall not relieve Contractor of its obligations to perform such work. Should City request additional work beyond that specified herein, Contractor shall charge, and City shall pay, a rate as mutually agreed upon in writing prior to Contractor performing the additional work.

3. All other terms and conditions of the Agreement, Addendum and Amendment are to continue in full force and effect as stated and agreed to in the Agreement, Addendum and Amendment.
