PAYMENT PROVISIONS. All invoices are due upon presentation. Unless specifically noted, all monies received will be applied to the oldest invoice on account. Interest will begin after thirty (45) days and accrue at a rate of 1% per month compounded monthly. Client is responsible for full amount

whether collected or not. Modifications to our invoices will be charged on an hourly basis. If client requires a Purchase Order number on our invoice, it must be provided along with this signed Proposal. If a Purchase Order is not provided, we are not responsible for its presentation on our invoices.

OTHER TERMS OF AGREEMENT

- 3 engineering, LLC herein called the consultant, makes no representation concerning the
 estimated quantities and cost figures made in connection with maps, plans, specifications, or
 drawings other than that all such figures are estimates only and the consultant shall not be
 responsible for fluctuations in cost factors.
- 2. Consultant makes no representations concerning soil or environmental conditions and is not responsible for any liability that may arise out of the making or failure to make soil or environmental surveys, or sub-surface tests, or general testing.
- 3. In the event that any changes are made in the plans and specifications by the client or persons other than the consultant, which affects the consultant's work, any and all liability arising out of such changes is waived as against the consultant and the client assumes full responsibility for such changes unless client has given consultant prior notice and has received from consultant written consent for such changes.
- 4. The consultant is not responsible, and liability is waived by client as against consultant, for use by client or any other person of any plans or drawings not signed by consultant.
- 5. The client agrees to limit the consultant's liability due to professional negligent acts, errors, or omissions of the consultant to the sum of the consultant's fee.
- 6. All fees and other charges will be billed monthly and shall be due at the time of billing unless otherwise specified in this agreement.
- 7. In the event that the plans, specifications and/or field work covered by this contract are those required by various governmental agencies and in the event that due to changes of policy of said agencies after the date of this agreement, additional office or field work is required, the said additional work shall be paid for by the client as extra work.
- 8. The client shall pay the costs of plan checking and inspection fees, zoning and annexation application fees, assessment fees, soils engineering fees, soils testing fees, aerial topography fees and all other fees, permits, bond premiums, title company charges, blueprints and reproductions and all other charges not specifically covered by the terms of this agreement.
- 9. In the event all or any portion of the work prepared or partially prepared by the consultant be suspended, abandoned, or terminated, the client shall pay the consultant for all fees, charges, and services provided for the project, not to exceed any contract limit specified herein. A twenty (20) percent restart fee of remaining balance left on contract will be charged for projects placed on hold a minimum of one (1) year. This does not take into account any changes that may be requested to be made to the site plan, or engineering documents.
- 10. Printing of plans, delivery charges and postage for other than our normal design requirements, as well as review fees, will be billed as an extra to the contract at cost plus ten (10) percent.
- Revisions, alterations or change orders requested by the client shall be deemed extra work. Consultant fees will be per the latest fee schedule.
- 12. This proposal is valid for sixty (60) days from date of preparation.
- 13. Client agrees to defend, indemnify and hold consultant harmless from any and all liability, real or alleged, in connection with the owner's performance of work in this project, excepting liability arising from the negligence or breach of contract of consultant.
