The site is generally located on the southwest corner of N. Powers Pkwy W. and W. Placone Ln. DISCUSSION AND ACTION. Assistant Planner, Alexander Bosworth presented. The Public Hearing opened at 6:15 pm. Sue Van Gosen of 41452 W. Luera Lane asked about the lights for the ball field or whether it would be a daylight only park.
