The outer perimeter and beer Gardens will have fencing around them with security at all entrances.

IDs will be checked at outer gates by security and separate wristbands will be given out for under 21 and 21 and over customers. Only 21 and over will be allowed into the beers gardens.

### Emergency plan:

All areas marked "EXIT" will have an area of about 6 to 8 feet of open area with a break in the fencing.

The areas will be clearly marked and easily accessible without any obstructions around them.

Prior to the event, we will coordinate with Off Duty Police, our security staff and employees.

In case of any emergency, they will Instruct people to move towards and out through the exits and towards either Panda Express to the north of the parking lot or towards the Urgent Care to the south of the parking lot.

This should allow ease of access for emergency vehicles and people.
