3.2 WS 17-02 The Mayor and City Council shall hear reports on meeting and/or conferences attended by Council.

Vice Mayor Chapados reported attending the Employee Rewards and Recognition Party and Luncheon on December 13th, she congratulated and thanked all the recipients for their service.
