


Subdivision Ordinance Project Update

- 2003 City adopts County Subdivision Code
- 2006 City adopts Maricopa Subdivision Ordinance
- 2016 Minor Text Amendment to City's Subdivision Ordinance.
- 2017 Initiate Major Update

Major Modifications to Ordinance

- Streamlining process and ensure meet AZ state requirements for hearings
- Creating firm and directed guidelines for extensions and modifications to existing and future subdivisions
- Inserting processing graphics, flowcharts and tables for better understanding of steps
- Correct Subdivision Ordinance to be inline with Zoning Ordinance and Design Guidelines



Zoning Code Coordinating Touch Ups

- Update Definitions
- Add Small Cell Wireless information
- Update Sign Code to match Federal ruling
- Update Zoning Code and Subdivision Code to compliment each other and not conflict with:
 - Design
 - Landscaping
 - Open Space
 - Density
