***Re: Agreement for Professional Services for the 2018-2019 fiscal year***

Dear Trisha:

Our office currently enjoys the opportunity to represent the City of Maricopa and would be pleased to continue our representation and association with the City of Maricopa. During the 2018-2019 fiscal year, we will have an attorney located in City Hall for two days a week, which will continue to be on Monday and Wednesday. The attorney will be available to primarily work on civil matters during that time. Rather than have this attorney fill out daily timesheets, the City will pay our firm a flat fee of \$5,250 per month for this attorney's services, which will be invoiced separately.

For all other work, which will include, but not be limited to, the City Council meetings, Planning and Zoning Commission meetings, general civil work, and City Court prosecutions, Fitzgibbons Law Offices, P.L.C., offers to renew our existing agreement for professional legal services with the City of Maricopa at the same rates as last year: All civil matters will be billed at the current rate of \$155.00 per hour, and all criminal matters will be billed at the current rate of \$135.00 per hour. As we have done in the past, we will submit monthly bills to the City of Maricopa, which will include any costs incurred on behalf of the City of Maricopa. The term of this renewal would be from July 1, 2018 through June 30, 2019.

If during the term of this renewal the City Council would like us to enter into a more detailed legal services agreement, please let me know and I will prepare an agreement for your consideration. As always, please contact us at any time if you have any questions or concerns.
