## 1. Call to Order

The City Council Regular Meeting was called to order at 7:06 p.m. Reverend Arnold Jackson gave the invocation and Councilwoman Gussee led the meeting attendees in the Pledge of Allegiance.

# 3. Proclamations, Acknowledgements and Awards

3.1 <u>PROC 19-06</u> Hispanic Heritage Month Proclamation

Mayor Price invited the Hispanic Chamber of Commerce to accept the Proclamation. He read the proclamation and proclaimed September 15 through October 15 as Hispanic Heritage Month in the City of Maricopa.

Councilwoman Gusse gave a brief statement in Spanish in honor of Hispanic Heritage Month. She introduced the dance group, Cuacualti and they performed a bailé folkorico. The meeting went into recess at 7:16 p.m. for a mariachi performance by Eloy High School band and refreshments. The meeting reconvened at 7:42 p.m.

# 4. Report from the Mayor

Councilmember Brown reported that members of Pinal County Water Augmentation Authority (PCWAA) attended the September 9th open meeting at the Babbit Center for Land and Water Policy. He stated it was held in conjunction with the Arizona Water Resources Research Center and that legislators were present.

Councilmember Smith reported on the latest Senior Lunch and Learn on finances. She stated the next one would be on Friday (September 20), presented by Susan Burke on the topic of pain and a 30 minute segment by Maricopa Unified School District (MUSD) Superintendent, Dr. Tracy Lopeman. She encouraged participation.

Vice Mayor Wade reported attending the 9/11 Memorial Service at the Copper Sky

Police Sub-Station, the 9/11 Flag Ceremony at Legacy Traditional School, and their breakfast for first responders.

Councilmember Vitiello reported also attending the 9/11 Memorial Service and thanked first responders for their service. He reported on the ribbon cutting ceremony for Wendy's on Friday, September 13.

Mayor Price reported speaking at Ak-Chin's Self-Governance Professionals Workshop and Strategy Session at the request of Chairman Robert Miguel on September 12. He emphasized on the importance of cultivating relationships.

8.5 <u>CON 19-22</u> The Mayor and City Council shall discuss and possibly take action to ratify a Purchase and Sale Agreement and Escrow Instructions with Electrical District No. 3 of Pinal County, a political subdivision of the State of Arizona for the sale of 10.19 acres generally located at the Southeast corner of Edison Road and Estrella Gin Business Parkway, commonly known as the Estrella Gin Business Park, for \$1.38 per square foot. Discussion and Action.

#### This Contract was Approved.

8.6 PUR 19-06 The Mayor and City Council shall discuss and possibly take action on approving the purchase of a 107' Pierce Ascendant Quint Fire Apparatus with funding from a lease purchase agreement with PNC finance (Pierce Financing Group) for a 3 year term. Payment funds (\$431,201.24 annually) will come from Fire DDIF monies in the city budget. To facilitate the first payment from fiscal year 2020 budget, a budget transfer will be necessary to move budget capacity from HURF (20055151-54432) of \$261,202 and General CIP (35022528-67742-32004) of \$170,000.00 to Fire DIF Fund (34422528-67742-32004). ## 9. Regular Agenda and/or Public Hearings

**9.1** ORD 19-13 An Ordinance of the Mayor and City Council of the City of Maricopa, Arizona, amending Section 2-82(1)(a)(1) of the City Code of Maricopa regarding Council established standing committees to combine the Cultural Affairs Committee and the Arts Committee. Discussion and ACtion.

Community Services Director, Nathan Ullyot explained that the Cultural Affairs Advisory Committee (CAAC) has struggled with attendance and meetings got canceled for lack of quorums. He stated staff could effectively combine the responsibilities of the CAAC with Arts Advisory Committee and elaborated. He opened the floor for comments and questions.

Councilwoman Gusse thanked Mr. Ullyot, Brandy Hughes and Erik Surber for the Hispanic Heritage Month programming for National Hispanic Heritage Month and asked if the Arts Committee would be taking over future cultural celebration programming. Mr. Ullyot explained that the committee would be taking more of an advisory role and elaborated. Councilwoman Gusse and Vice Mayor Wade reiterated thanks to Mr. Ullyot and his staff.

Mayor Price asked how the few participating committee members would be merged with the Arts Committee. Mr. Ullyot commended all members and responded that they would notify the two participating members and stated he was confident they would understand. He stated that one of them might want to fill the vacancy in the Arts Committee.

Councilmember Smith commended Mr. Ullyot and the adjustment of the committees. She encouraged celebrating all heritages in one event. Vice Mayor Wade stated that was the direction the committee wanted to take

A motion was made by Councilmember Brown, seconded by Vice Mayor Wade, that this Ordinance be Approved. The motion carried by the following vote:
