1. Call To Order

4.1 [MIN 17-82](#)

Approval of Minutes from the August 14, 2017 meeting.

Vice Chair Sharpe motioned to approve the minutes from the August 14, 2017 Planning and Zoning Commission meeting. Commissioner Potter seconded the motion. Motion passed unanimously.

5. Agenda and Public Hearings

5.1 [PAD16-04 \(2\)](#)

PUBLIC HEARING Anderson Russell Planned Area Development (PAD) 16-04: Applicant Kelly Hall of Phillip Miller Consultants, LLC is requesting a rezone to Planned Area Development on approximately 776 acres generally located south of the intersection of Anderson Road and Maricopa-Casa Grande Highway. Discussion and Action.

Planner Ryan Wozniak approached podium and informed the Commission that the applicant had requested a continuance.

Chair Huggins opened the Public Hearing. No one from the public approached. Chair Huggins closed the Public Hearing.

ZON17-01 PUBLIC HEARING: A request by Global Water Resources, Inc. to rezone 31.18 acres, assessor parcel number 510-12-001C, 001D, and 001E, generally located at the NWC of Powers Pkwy and Placone Road. Zone change request from existing CI-2 Industrial Zone (former Zoning Code) to General Industrial (GI), as identified in the current Zoning Code. Discussion and Action.

Senior Planner Rodolfo Lopez requested to combine Agenda Item 5.2 and Agenda Item 5.3 as one presentation and discussion item with separate motions. He then presented Agenda Item 5.2 and 5.3.

The item was discussed. Commissioner Irving motioned to approve Agenda Item 5.3 with the stipulations set forth by City staff and with the assurance bonds for 2 year renewals included. Commissioner Joyce seconded the motion.
