### 1. Call to Order

*The City Council Regular Meeting was called to order at 7:03 p.m. Maricopa Lutheran Church Pastor, Glenn Zimbelman gave the invocation and Councilmember Wade led the meeting attendees in the Pledge of Allegiance.*

#### 3.1 [PRES 18-14](#) Rocket Challenge/Science City Update

*Councilmember Smith gave information on the 4th annual Rocket Challenge hosted with the blended learning classes of Maricopa Unified School District (MUSD) Maricopa Wells and Desert Winds Middle Schools. She explained that the blended learning classes concentrate on Science, Technology, Engineering, Arts and Math (STEAM). She acknowledged the following sponsors: City of Maricopa, Rose Law Group and Southwest Gas. She turned the presentation over to STEAM Foundation Chairman, Dan Miller. He gave an overview of the challenge and provided photos of event. *Interim City Manager Trisha Sorensen recognized Interim Community Services Director Fred Gray. Mayor Price presented Mr. Gray with a basket of Copper Sky memorabilia. Mr. Gray gave a brief statement and thanked the City Manager, his staff and directors.*

**6.      Call to the Public**

*Mayor Price acknowledged the amount of pickleball court supporters in the audience.*

*William Latous spoke in support of new pickleball courts. He stated pickleball tournaments were a revenue opportunity and elaborated.*

*Beth informed the public that during the work session there was a line item for over \$400,000 in the Capital Improvement Program (CIP) for pickleball courts. She gave a brief statement in support of new pickleball courts.*

- 9.1 [CON 18-15](#) The Mayor and City Council shall discuss and possibly take action to approve the Agreement with Breinholt Contracting Company, Inc. in a total amount not to exceed \$22,500 for the demolition of six existing buildings in the Heritage District, and authorize the City Engineer to approve change orders in an additional amount not to exceed \$20,000. Funding for the project will be drawn from Grants Capital Improvements, Engineering, Technical, Community Development Block Grant (35255155-53340-15504). Discussion and Action.

- 9.2 [PUR 18-10](#) The Mayor and City Council shall discuss and possibly take action on approving a purchase from Diversified Flooring Services for the purchase of replacement of the carpet in the library. This includes moving of furniture, exisiting carpet and adhesive, floor patching and repair, carpet tile, labor, freight, delivery and tax. Funding will be paid from Capital Project Fund, Library, Furniture and Fixtures (35033135-67730-38005). Discussion and Action.

**This Purchase was Approved.**

- 9.3 [CON 18-19](#) The Mayor and City Council shall discuss and possibly take action on approving a job order with SDB Construction in an amount not to exceed \$17,095.00 for the installation of two doors plus badge readers in the front desk area to enhance staff security and authorize the City Engineer to approve change orders in an additional amount not to exceed \$7,905.00. Funding for this job order will be drawn from General Fund, General Government, Contingency (10010000-99000). Discussion and Action.

- 9.4 [MISC 18-10](#) The Mayor and City Council shall discuss and possibly take action on approving the 2018 updated Title VI Non-Discrimination Implementation Plan related to Section 5311 transit funding. Discussion and Action.

- 9.5 [CON 18-18](#) The Mayor and City Council shall discuss and possibly take action on an amendment to the Interim City Manager Employment Agreement with Trisha Sorensen to extend the term and increase the compensation amount. Discussion and Action.

- 10.1**     **MISC 18-11**     The Mayor and City Council shall discuss and possibly take action to approve a SR347 Special Event Signage Program that will assist businesses affected by the State Route 347 Grade Separation project with additional signage to what is allowed in the current Zoning Code 409.12.
