*Mayor Price explained the proposed cancelations were due to the Fourth of July holiday and the Arizona League of Cities and Towns Conference.*

**10.5**     **ORD 18-02**

An Ordinance of the Mayor and City Council of the City of Maricopa, Arizona, amending Section 3-21(e), Section 3-21(g) and Section 3-41 of the Maricopa City Code regarding the authority of the City Manager and providing for severability and declaring this ordinance to be an emergency measure that is operative immediately as provided by law. Discussion and Action.

*City Attorney Denis Fitzgibbons explained that approval of this Agenda Item would give the City Manager more flexibility with the budget, moving money between funds and moving personnel positions without always coming back to Council for approval. He stated that in the end, Council would always approve the organizational chart during the budget process. Interim City Manager, Trisha Sorensen clarified this would not give the City Manager approval to add positions nor authorization to increase the budget. She reiterated that it would give the City Manager the flexibility to move things around as the need arose.*

*Mayor Price further elaborated on the roles of the City Council and the City Manager. Councilmember Smith requested that the item be reviewed in a year to ensure that it worked the way it was intended to be used. Vice Mayor Chapados asked for*

*clarification. Councilmember Smith clarified that she did not want the language of the ordinance language amended; however she would like to approve it with an additional note that there be a review.*

**A motion was made by Councilmember Smith, seconded by Councilmember Wade, that this Ordinance be Approved as presented and a review be made within 1 year. The motion carried by the following vote:**
