		City Manager Horst stated that adoption of the tentative budget will come before council on May 18, 2021 with the final budget adoption on June 15, 2021.	
	He then stated that staff is requesting nine new positions for the next FY. He then presented where the money comes from for CIP projects, followed by where the money is spent.

City Manager Horst then informed the Finance Department will now be the Office of Business Management. He added that this change will take more of an analytical approach to some things done by the City.

He summarized stating that we are adding staff and lowering taxes yet our expenditures are less than last year. He stated that come July 1, the Family Advocacy Center will transfer to Pinal County, if approved by the County. He also added that they're researching what to do with Dispatch. Discussion ensued.
