Councilmember Marsh reported attending the following events: the Friends of the Arts meeting at the library, a Historical Society meeting, two Pinal County Water

Augmentation Authority Board meeting, the Pinal Partnership Basin Study, and the Central Arizona Project University Training and Update. He elaborated on items discussed.

Councilmember Liermann reported attending the Chamber Breakfast meeting and elaborated on the new business offering mental health services.

Vice Mayor Smith elaborated on the new Friends of the Arts group. She stated that she, along with Mayor Price and Councilmember Lierman, they listened to the needs of the arts group.

Councilmember Wade announced there would be a Juneteeth celebration at Pacana Park from 6 to 9p.m. He also announced that the U.S. Senate passed the resolution to declare the Juneteeth a national holiday. Lastly, he stated the Councilmember on the Corner was hosting the youth mock city council every Sunday, except the following Sunday due to Father's Day.

Mayor Price stated that as Chair of the Transportation Sub-Committee of the League of Cities and Towns, they were working to create a rural sub-committee of transportation and elaborated. Next, he gave information on Proposition 416-417 and elaborated on the half-cent sales tax. He encouraged residents to reach out to friends and family in Maricopa County to vote on 400. He reported that the Gila River Indian Community recently sent the congressional delegation of Arizona and the Arizona Department of Transportation Director a letter stating that SR 347 was one of their top 3 priorities in transportation needs.

6. Call to the Public

Gale Randolph gave information on the new organization, Citizens Supporting Our Community. She stated the organization would be introduced on the Juneteeth at the library from 10 a.m. to 12 pm. on Saturday. She invited the public to attend.

Princess Blessing stated that due to the needs in the city, they opened a 24 hours residential group home. She elaborated on the group home and the services offered. She encouraged members of the council to tour the facility.

Councilmember Wade gave information on the second annual LGBTQ Family Festival at the library on June 26 at 8 a.m.

Gala inquired why the Maricopa Police Department did not have a complaint form. She was directed to contact Chief Hughes.

Mrs. Bellinger spoke in opposition of LGBTQ book displays in the library.

Discussion and Action.

This Intergovernmental Agreement was Approved.

7.2 RES 21-30 A Resolution of the Mayor and City Council of the City of Maricopa, Arizona, declaring as a public record that certain document filed with the City Clerk and entitled "Amendment to Title 3: Administration and Personnel," regarding the update of rules and regulations relating to the Acting City Manager, authority to contract and duties of the Purchasing Director and amending Section 3.10.100, Section 3.10.140 and Sction 3.65.040 of the Maricopa City Code. Discussion and Action.

7.3 ORD 21-09 An Ordinance of the Mayor and City Council of the City of Maricopa, Arizona, adopting "Amendment to Title 3: Administration and Personnel" by reference to amend Section 3.10.100, Section 3.10.140 and Section 3.65.040 of the Maricopa City Code and providing for severability and the effective date thereof. Discussion and Action.

This Ordinance was Approved.

7.10 CON 21-14 The Mayor and City Council shall discuss and possibly take action on approving a Purchase and Sale Agreement and Escrow Instructions with S3 BioTech, LLC, an Arizona limited liability company, for the sale of approximately 4 acres generally located on the southeast corner of W. Bowlin Road and N. John Wayne Parkway, for \$1,375,000.00 and authorizing the City Manager to execute any necessary documents related thereto. Discussion and Action.

This Contract was Approved.

8. Regular Agenda and/or Public Hearings

8.1 PRES 21-09 The Mayor and City Council shall hear a presentation by Chief James Hughes on the 2020 annual report of the Maricopa Police Department, regarding the use of force by the department Discussion Only.

Maricopa Police Department (MPD), Chief Hughes gave a PowerPoint 2020 annual report on the department's use of force. He discussed the department's use of force procedures including on scene investigations and reporting. He detailed the procedures of the review board, the total number of incidents, the frequency of force being used and the use of force demographics. He compared the statistics to the 2019 numbers.

Mayor Price thanked the police department and commended their focus on de-escalation and level of transparency.

Councilmember Wade asked if there was a process to identify individuals/officers who use force more often. Chief Hughes responded there was an early warning system and elaborated. A brief discussion ensued.

The Presentation was heard.

8.2 PRES 21-11 The Mayor and City Council shall hear a Public Safety update. Discussion only.

City Manager Horst discussed the Future Planning Process and the requirements for navigating the path forward. He elaborated on the city's background and growth. He detailed the list of guiding principals used to determine whether the police dispatch was serving the public in the best way. He elaborated on the evolution of emergency communications. He played a video from the City of Chandler dispatch and the services they provide. He stated that the City of Chandler asked to pause the study process and elaborated. He stated that the State of Arizona encouraged consolidation and offered funds, and elaborated on the benefits. He stated that based on the objectives and the desire to upgrade services, it was determined that the best option was to pursue a new facility within the city, large enough to meet the city's present and future needs, and the capability of hosting future partners and other inner-city services and functions such as 311. He stated a study would be propelled by the condition and functionality of the existing facility, the opportunity to repurpose the existing facility in support of potential new development and the end of the life cycle of current software/hardware components. He stated the City of Maricopa Fraternal Order of Police Union Lodge 78, and the City of Maricopa Police Association (COMPA) expressed opposition and concern in regard with dispatch operations. He stated he sat down with union representatives along with Assistant City Manager, Brown, Chief Hughes and Public Safety Communications Manager, Jennifer Hagen and all concluded to let the study continue until findings were presented. He announced that the land at Copper Sky would be repurposed to a medical campus with a specialty emergency, (ER) hospital and elaborated. He stated a new police station would be built and upgraded by the court house. He explained how the new police station could be built without debt and benefit everyone. He announced Jennifer Hagen would be charged with the project.

Mayor Price thanked staff, City Manager Horst and all those involved.

The Presentation was heard.
