- 7.3 [CON 22-15](#) The Mayor and City Council shall discuss and take action to approve a Purchase and Sale Agreement and Escrow Instructions with Geston Duffy Company, LLC, for the sale of approximately 4.22 acres of real property generally located on the southeast corner of W. Edison Rd. and N. Wilson Ave., for an approximate purchase price of \$1,424,629.80 which represents \$7.75 per sq ft, and authorizing the City Manager to execute the agreement, any future amendments to extend closing and any other necessary closing documents related to this agreement. Discussion and Action.

## 8. Regular Agenda and/or Public Hearings

- 8.1 [APP 22-01](#) The Mayor and City Council shall discuss and possibly take action on making an appointment to fill the vacancy on the Cultural Affairs and Arts Advisory Committee. Discussion and Action.

*Councilmember Marsh stated he was not ready to nominate an appointment and encouraged anyone interested to apply. Councilmember Wade nominated Danielle Lemorin for appointment.*

**A motion was made by Councilmember Wade, seconded by Vice Mayor Manfredi, that this Appointment be Appointed. The motion carried by a unanimous vote.**

- 8.2 [PH 22-04](#) The Mayor and City Council shall hear public comment regarding a Minor General Plan Amendment requested by the City of Maricopa on behalf of Iplan Consulting to amend the General Plan Future Land Use Map (GPA22-03) for approximately 111 acres from existing Low Density Residential (LDR) to Master Planned Community (MPC), generally located at the northwest corner of the W. Ruben Dr. and N. Ensenada Rd. road alignments, or approximately 0.5 miles west of N. Anderson Rd. and 0.65 miles north of W. Teel Rd.

*Assistant Planner, Alexander Bosworth gave a brief PowerPoint presentation. He detailed the request by the City to amend the General Plan Future Land Use of the subject property on behalf of Iplan Consulting. He explained the request was a corrective measure to the previously approved General Plan Amendment case to include the land under the Low Density Residential future land use designation of Parcel # 502-15-002B which was initially intended to be a part of the aforementioned approved General Plan Amendment, but was inadvertently left out of the site exhibits and staff reports by mistake. He displayed aerial maps of the site, and the general plan map. Lastly, he reported the Planning and Zoning (P&Z) Commission recommended approval of Minor General Plan Amendment case #GPA 22-03 on March 25, 2022. The public hearing was opened at 7:33 pm.*

*Kenneth Carter expressed concerns that it would disrupt the lifestyle of the community and that it would disrupt burrowing owls. He suggested designating it an equestrian community to maintain the feel.*

*Dave Klingsman discussed water shortage concerns and with the notification system. He stated some community member were not notified of the community meeting.*

*Mayor Price asked the City Attorney if the legal requirements were met for the citizen participation plan. City Attorney, Denis Fitzgibbons confirmed that staff complied with all the necessary requirements. Planning Manager, Rick Williams further elaborated that this was a corrective measure and nothing else had changed. The public hearing closed at 7:46 pm.*

**The Public Hearing was held.**

- 8.3     **RES 22-21**     A Resolution of the Mayor and City Council of the City of Maricopa, Arizona, approving and adopting a Minor General Plan Land Use Amendment to change the land use from Low Density Residential (LDR) to Master Planned Community (MPC) on approximately 111 acres generally located at the northwest corner of the road alignments of W. Ruben Drive and N. Ensenada Road as requested by the City of Maricopa on behalf of Iplan Consulting in case #GPA 22-03. Discussion and Action.

**A motion was made by Vice Mayor Manfredi, seconded by Councilmember Liermann, that this Resolution be Approved. The motion carried by a unanimous vote.**
