PUBLIC HEARING: A request by the City of Maricopa to rezone approximately 8.47 acres from existing underlying CR-3 (Single Family Residential) zoning and the overlay Lakes at Rancho El Dorado PAD (Planned Area Development District), to OS-PR (Parks and Recreation Open Space). The site is generally located on the southwest corner of N. Powers Pkwy W. and W. Placone Ln. DISCUSSION AND ACTION.

Assistant Planner, Alexander Bosworth presented. The Public Hearing opened at 6:15 pm. Sue Van Gosen of 41452 W. Luera Lane asked about the lights for the ball field or whether it would be a daylight only park. The Public Hearing closed at 6:15 pm. Discussion ensued in favor of the park.
