PUBLIC HEARING: PAD22-03 District 3 at Copper Sky: A request by S3 BioTech LLC represented by Mr. Britton Lee, Chairman and CEO of S3 BioTech, is proposing to a rezone approximately 28.3 acres of land from existing General Mixed Use (MU-G) and Transitional (TR) Zoning District to Planned Area Development (PAD) District, for a proposed a Medical and Innovation campus. The property is generally located at the southeast corner of N. John Wayne Pkwy and W. Bowlin Rd. Discussion and Action.
