The Mayor and City Council shall discuss and possibly take action on approval of an agreement with Waste Technologies LLC d/b/a Right Away Disposal for Recycling and Household Hazardous Waste Collection Services in an amount not to exceed \$192,000 a year, to be paid from the General Fund, General Government, Professional and Occupational (10010000-53320) and approve a budgetary transfer in an amount not to exceed \$20,000 from General Fund, General Government, Contingency (10010000-99000) to General Fund, General Government, Professional and Occupational (10010000-53320). This award is in accordance with the City of Maricopa Purchasing Code, Article IV, Section 3-215, Bidding Procedure. Discussion and Action.

On January 7, 2015 the City of Maricopa posted an RFP for Recycling and Household Hazardous Waste (HHW) Drop-Off Station Operation (RFP 15CM122314). That RFP closed on January 20 at 2:00 p.m. The RFP selection process has been concluded and Waste Technologies LLC (Right Away) has been deemed the most responsive applicant.

Based on the requirements of the RFP and the proposal provided by Right Away, staff has negotiated a contract containing the following deal points:

Right Away will:

- · Set up and operate a household recycling drop off site that will be open 6 hours on Saturdays
- · Accept at a minimum paper, cardboard, plastics (#1-#7), aluminum cans, tin cans, glass bottles, appliances, and tires at no charge
- · Accept bulk trash at a rate of no higher than \$15.00 per yard or \$5.00 per bag
- · Be allowed to offer additional recycling related services
- · Hold household hazardous waste events based on future approval of funding by the City at a rate of \$30,000 per event maximum of two per year

The City will:

- · Provide Right Away a two acre site within the City for operations
- · Pay Right Away \$10,000 per month for services provided at the site
- Pay Right Away \$1,000 per each additional rollaway above the 12 rollaways included in the initial contract price up to \$12,000

The projected cost of this contract is between \$120,000 and \$132,000 based on the number of tires collected. Council has the option of approving additional funds for HHW events for an additional \$60,000. This contract will not exceed a total maximum cost \$192,000.

Approval of this Recycling and Household Hazardous Waste Collection Services Contract will allow Right Away to initiate service in Maricopa at a site to be approved by Council

Staff is requesting a \$20,000 transfer from contingency in order to cover funding for the month of May and June.

Staff recommends the Mayor and City Council approve an agreement with Waste Technologies LLC d/b/a Right Away Disposal for Recycling and Household Hazardous Waste Collection Services in an amount not to exceed \$192,000 a year, to be paid from the General Fund, General Government, Professional and Occupational (10010000-53320) and approve a budgetary transfer in an amount not to exceed \$20,000 from General Fund, General Government, Contingency (10010000-99000) to General Fund, General Government, Professional and Occupational (10010000-53320). This award is in accordance with the City of Maricopa Purchasing Code, Article IV, Section 3-215, Bidding Procedure.
