Public Hearing. The Mayor and City Council shall hear public comment, discuss and possibly take action to approve Resolution 23-71, a request by Pounders Engineering, on behalf of David C Morgan 401k Profit Sharing Plan, to amend the city's General Plan Land Use Map, on approximately 20 +/- acres from Mixed Use (MU) to Low Density Residential (LDR). The site is generally located at the northwest corner of W. Santi Rd. and N. Gunsmoke Rd.
