The Contract for QC Intra Metro Ethernet has no initial cost, a monthly recurring charge of \$855.44, a minimum service period of 12 months, and a Special Construction Cost of \$31,900. The Special Construction Cost may be waived if the City continues the service for a minimum five year Contract Term. If the City terminates the Contract prior to the five year term, the City may be required to pay a prorated portion of the Special Construction Cost. The Contract for QC Intra PRI ISDN has no initial cost, a monthly recurring charge of \$299.00 and has a minimum service period of 12 months. Funding for these contracts will be drawn from General Fund, Police Support, Phone Service (10022123-55530). Discussion and Action.
