Based on City Council’s direction from the presentation on visioning strategy presented at the May 20, 2014 Regular Council Meeting, staff is bringing forward a contract with Neu & Company to provide a Visioning 2040 Strategic Plan. Neu & Company, as our consultant, will assist the City's Project Leader, the Steering Committee, participants in the Community Forums, and the members of the Issue Project Teams in the processes and overall effort to create the Visioning 2040 Strategic Plan. The contract includes funding for training, meetings, and briefings.
